Once the form is submitted and validated, relevant data for employees who fall into category one above will be automatically pushed to the public database on a regular basis. If an employee in category two or three is authorized for outside employment, the relevant data will be manually added to the database. Any data responsive to this Motion generated on or after the date of the Motion but before November 1, 2022, will be manually added to the database prior to publication. The public database will go live on or before November 1, 2022, and a formal notice will be submitted to the City Council upon its publication.
