### Special recognition

#### 1. Donation to Floyd County School Board of Education Child in Need Fund

Chair Hancock stated this was County Clerk Elrod's idea. She brought the idea before the commission to collect parking fees in the month of August and September and then donating them to the Child in Need Program. The total was \$3,680.35. He thanked the Board of Education for everything they do and the close working relationship they all have.

# FIRST READING (SECOND READING TO BE HELD ON DECEMBER 10, 2019)

#### 1. FY20 BUDGETS

County Manager McCord stated they had extensive conversation in caucus. He highlighted that they have seen some growth in the tax digest, property tax has been an increase with a ninety-eight percent (98%) collection rate. There were some increases in TAVT with the formula change this past July, and the local option sales tax (LOST) is timely that they have seen the increases in revenues because they also have increases in expenditures to offset it. Overall, \$3.2M almost \$3.3M in increase revenues projected for 2020. On the expenditure side, they are at \$3.5M additional expenditures, some of this is a two percent (2%) cost of living adjustment (COLA) and a two percent (2%) merit budgeted. Health insurance increased over \$800,000.00 on the county portion, with a minor increase for employees during open enrollment. There have

been some savings in pension, also in Workers' Compensation. The medical department for inmates is going over the minimum on a regular basis, so they will be taking a look at the contract at a later date to make sure they do not need to renegotiate the minimum number of inmates being seen. They are almost where they were last year with a \$325,000.00 more deficit than this time last year. They have met with almost all department heads and elected officials that have had any special requests, they have done a good job in requesting and finding a combination to make it work. As they stand in the general fund, they are at a \$3.5M deficit, they were at \$3.2M last year. Compared to current budget they are \$2.4M, and they will review this again mid-year. Overall, it is a solid budget, Mrs. Gass has done a great job. One additional, he does not have the final budget yet. He discussed it a few weeks ago regarding an additional full time position at the Cave Spring Fire Department to go in conjunction with the Cave Spring Fire Agreement.

# SECOND READING (FIRST READING HELD ON NOVEMBER 12, 2019)

Chair Hancock explained the procedure of the public hearing; each person recognized shall come to the podium and state his or her name and home address. Mr. Brice Wood, Rome Floyd Planning and Zoning Department, stated the visual aesthetic would not deviate much, if at all. This is one of the larger Community Commercial lots that has been rehabilitated, previously it had a trash problem. He presented photographs of the area and surrounding area and stated this was a unanimous vote by staff and the Planning Commission to approve.
