PUBLIC PARTICIPATION

Susan Harrell, 5109 Fosters Mill Road, Cave Spring, Georgia, stated that they be careful with any changes that they make with the ULDC because it will have repercussions in the entire county. This goes against the long term comprehensive plan for Cave Spring and could lead to litigation. After speaking to individuals on the state and regional level she was told that the commissioners zoning, as well as planning are under an obligation to protect the zoning in the area. There are several areas of the county that are in violation of zoning and it seems like no one can enforce it or has the desire to enforce it.

Terri Wright, 5100 Fosters Mill Road, Cave Spring, Georgia, from day one those trying to change the zoning for Melson Road have claimed it is a done deal in their favor, you have admissions of zoning violations on their part in writing and verbal admissions from them in minutes. Since May they have been trying to get the county to enforce these violations, to no avail, which leads to appear that it is a done deal. In drafting the changes for the ULDC zoning has reached all the way to Indianapolis to find wording to fit this narrative. She was told the reason for this is they could not find much out there to go by. Appearance is they had to leave Georgia to fit this narrative. The fact is every county around has addressed this for years already. In reaching out to a local county yesterday, she explained what she was lead to understand and they were surprised that the development of Northwest Georgia Regional Planning Commission is not participating with guidance and advice even though Floyd pays dues to them, works for them, they are more than willing to help, but no one has reached out for them or any neighboring county. She is asking again in this open public meeting, on public record, to please enforce the current zoning violations of Melson Road. As she discussed with Brian Roberts, she has been reaching out to the EPA and EPD since this whole thing started. There is no reporting no reporting on the Mastros or Grace Industries, except a v permit considered a minor source for their armor and shield business. There is no reporting or permits by name or address for a million dollar a year metal fabrication company Grace. Now they want to come to Melson Road for artesian and crafts, though it keeps changing to fit the narrative of the time. Everything they have given in writing and said at meetings along with other documentation she has acquired shows that their intentions are not that of a hobby or so called cottage industries. They are in complete support of cottage industry which is secondary to the home, and more often and properly referred in Georgia ULDC as home business. Surrounding counties spoke of the importance to fashion their ULDCs to flow with neighboring counties with an emphasis on their comprehensive plan. In all of this she received a quick education of 1989 planning act and qualified local government. Floyd County is way behind on the ULDC reform and for the sake of Floyd County please do not allow this to be like or national democratic impeachment scenario. Haphazard reform could prove disastrous and if it turns legal one day it will end up on the shoulders of the tax payers.
