Commissioner Hufstetler stated that they have two years to put this in place, but this will essentially mean that the government accounting will be done as a business would do, classify assets and depreciate them. Comptroller Al Leonard had stated in the Caucus Session that this will require two sets of books for a while. Commissioner Hufstetler stated that he felt it will make the accounting more meaningful, but they will need help, so he is requesting and making a MOTION that they approve \$5,200 for the University of Georgia Institute of Government to perform this consulting work. # AUTHORIZE APPROVAL OF **REVISED BUDGET.**

Commissioner Hufstetler stated that this was reviewed in the Caucus Session and they had looked at areas of increasing revenue. Some of these would be Sheriff's Fees and Boarding Inmates, Local Option Sales Tax and Interest Earned. The budget originally was for \$400,000 for Interest Earned and he stated that they will realize at least \$700,000. There have been some cost increases, with the jail full there were additional costs, gas and oil, group insurance, and previously mentioned items for Juvenile Court. The revised budget will allow the departments to continue and will increase the fund balance. Commissioner Hufstetler made a MOTION that the Revised Budget be approved. #### COUNTY EMPLOYEES SALARIES.

Commissioner Hufstetler stated that as discussed in Caucus, as part of the study mentioned by Commissioner Mahanay about a month ago regarding working on employee salaries, they all agreed they wanted to go ahead and implement a cost-of-living increase of 3.71% effective immediately. As an example, a starting police officer would increase the pay to \$24,000 which will equal the increase just implemented by the City of Rome. This will be for all employees in every department. He stated that there are other parts of the study down the road. Commissioner Hufstetler made a MOTION that a cost-of-living increase of 3.71% be implemented, effective immediately. It was clarified by Commissioner Mahanay that this will be effective with the next payroll. SECOND by Commissioner Mahanay.

Commissioner Hufstetler noted that this is one of several increases this year, so the average increase this year will be between 8 and 9% for employees, some with their merit increase could make higher. Commissioner Fricks stated that they feel the employees have done their duty this year. When they look at the revised budget and the two departments which were over budget, were justifiable and every other budget had been under budget. They have performed well and added more to the Fund Reserve. Commissioner Jennings noted that the employees had increases in insurance and the Commissioners are aware of the reduction in take-home pay and that the cost of living has increased. He stated that he felt this is a timely increase.

Commissioner Fricks stated that regarding recreation, they are looking at a 45-acre tract of land adjacent to the Armuchee High School for a park in Armuchee. It will be paired up with Greenspace Preservation funds and they are working on negotiations for the property. Chairman Mayes stated that he looks forward to working this out in the near future. Commissioner Fricks stated that this is a good time since we are ending with a good year for the budget. Commissioner Jennings noted that this is the first step, that the park will be in-process for a number of years, but it says that we are serious about a park in Armuchee. Commissioner Fricks stated that the plan they are looking at is a 25-year plan, which should fill the needs of the area for 25-years. If this is not done through a S.P.L.O.S.T., then it will be done through phases, with the first phase to be to secure a buildable tract of land. The projected facilities were reviewed by Commissioner Fricks. Commissioner Hufstetler noted that there are other possibilities for land, but this is the most promising at this time.

### **OTHER BUSINESS:**

County Manager Kevin Poe stated that regarding pigeons, that he is available for questions. He stated they did not go into this blindly, a lot of research had been done and they had received information through the internet and various sources. He stated that there is a problem with damage to public property and also a health hazard. They had researched different ways to eliminate the problem. Their intention never was to kill any pigeons, the method they installed was to relocate or repel them from their roosting place on the steeple of the courthouse. They had obtained advice from experts and felt that in the long term this would be the best way to handle the problem. The cost to bait the steeple was \$500 and \$100 per month to keep it ongoing. It is an approved method by the Department of Natural Resources, it is not illegal and it is not a product which can be bought over the counter. The Department of Agriculture does approve it to be used by licensed professionals and we did hire a licensed professional to install the bait. Our intent was not to poison or kill the pigeons. He apologized if he had offended anyone by the action he took, he had good intentions. He stated that he can provide documents where they sought and received advice. Chairman Mayes stated that he was not questioning County Manager Poe, he felt that he acted responsibly. County Manager Poe stated that obviously there is still a problem. Chairman Mayes asked if there were suggestion for other methods. County Manager Poe stated that there were other methods available. They had looked at starting from scratch, clean everything up and bait it. It was a cost of approximately \$15,000 for someone to clean it up, so that we can start from scratch again. He again apologized if anyone felt he was doing something inhumane to any animals, this was not his intent. Chairman Mayes thanked County Manager Poe for clearing this up and shedding light on it.

# **ATTORNEY'S REPORT:**

County Attorney Wade Hoyt stated that he had an item which requires a 4/5 vote to be placed on the Agenda. It is a request to authorize the Chairman to execute the **Professional Services Agreement** with **R. W. Beck, Inc.**, an engineering firm in Orlando, Florida. They are highly recommended through the Georgia Municipal Association in reference to engineering services for cell towers and the placement of cell towers. Their rate is \$145 per hour and the maximum hours on this contract will be 32 hours. This will be basically a maximum of \$5,000. They hope that it will not reach that amount, and that he will not have to come and testify before the Commission. He requested that there be a Motion to place this on the Agenda. MOTION was made by Commissioner Mahanay for authorization to execute the Professional Services Agreement with the R. W. Beck, Inc. engineering firm be placed on the Agenda. SECOND by Commissioner Jennings. VOTING:

There will be a public meeting on Monday, November 6, 2000, at 6 p.m. regarding an application for an asphalt plant on that quarry site. The State E.P.D. is holding a public hearing on the asphalt plant prior to giving them a permit. This meeting will also be held at the First Baptist Church in Cave Spring.

On November 9, 2000, at 7 p.m. Florida Rock will present to the citizens of the valley their plans for the quarry. There is the possibility that tours of the quarry site will be available. The meeting will be held in Cave Spring.

Commissioner Fricks asked if the pure water group had been meeting regularly. He had received a communication recently that the Commissioners did not care because they had not attended a past meeting. He stated that he had not received notification of the meeting. Commissioner Jennings stated there was an Annual Meeting in September, in August there was another meeting. He stated that he will see that their names are on the mailing list.
