Ms. Hiller stated the property was formerly used as a textile plant, and the current owner is planning to continue with use as a textile plant. Ms. Hiller stated the Planning Commission recommendation is that the lot that is currently zoned L-I would be zoned H-I in its entirety and the lot that is currently zoned S-R would be zoned H-I only for the part of it that actually is developed with buildings and parking lots right now. Ms. Hiller stated this would prevent putting H-I zoning right behind the houses that are currently along Avenue F. Ms. Hiller stated the applicant was amenable to this and understands that the recommendation was conditioned on him coming in with a plat to re-plat that lot and make just the part that is actually developed H-I, and leave the rest as S-R. Ms. Hiller stated she would also recommend that a condition also be placed that upon submission of a recordable plat that shows the lot divided in such a way that the industrial buildings and parking lots would all be zoned H-I and the remainder of the S-R lot would stay S-R.
