FEBRUARY 14, 1963

The City Commission of the City of Panama City, Florida met on the above date at 2 p.m. with the following members present: Mayor-Commissioner Joe E. Hutchison, Commissioners J. E. Hampton, Neal G. Goss and T. Brannon Copeland. Absent: Frank Dama.

The Mayor presided and explained that the purpose of the meeting was to approve the ballot, designate the polling places and the poll workers.
