City Attorney

City Attorney Cirullo made a report about neon open signs. At the August 23rd City Commission meeting, the Commission asked Lighthouse Point Chamber members to make some recommendations regarding this type of signage. The Chamber responded in an email dated November 17th and made the following recommendations: the static, temporary illuminated signs shall be the plug-in variety, and will be illuminated only during operating hours. The signs will not exceed 18" x 36" and will be positioned approximately 24 inches from top of window frames. The signs will be in the standard colors of red and blue neon.

City Administration's position is that the Chamber's proposal is reasonable and fair. City Attorney Cirullo does not find it necessary to change the Code.

Consensus of the City Commission was that no building permit will be required for a temporary (plug in) neon open sign. Open signs will not be calculated in the square footage of a window sign. Businesses with corner units or entrances on opposite ends of the building may use two signs. City Administration will communicate back to the Chamber that this is an acceptable alternative.

Committees

Joe Debuwitz, resident of Lighthouse Point Gardens North and Chairman of the Condominium Liaison Committee, reported on the first Condo Connection meeting held on November 28, 2011. Public Requests from the Floor:

Brent Anderson, 3940 N.E. 27 Avenue, Lighthouse Point, addressed the Commission regarding the 22-unit complex at Sunland Terrace, 2100 N.E. 39 Street. Mr. Anderson also owns a condo unit in Tarelton Manor. Mr. Anderson was concerned about the lack of communication with the City and its residents about the purchase of the property by BHP Community Land Trust, Inc., in May 2010. He was concerned about property values as a result of the purchase, and wanted to know what steps may be taken in the future to prevent similar purchases.

Mayor Schorr provided some history of the building. The project passed through Broward County, unbeknownst to the City.

Sharon Swiecicki-Fay, 4000 N.E. 27 Avenue, Lighthouse Point, was concerned over the purchase of the Sunland Terrace property as well. She researched the project and found it had been presented at several County Commission meetings. Ms. Swiecicki-Fay was concerned about the lack of communication between the County and the City regarding the purchase.

Communications:

The Mayor congratulated Mike Long, who will serve as City Commissioner for another 3-year term.

Commissioner Gordon congratulated Police Chief Licata on the arrival of his new granddaughter, Madelyn Marie.

Commissioner Long briefly discussed billboards, and the possibility of preparing an ordinance with regard to electronic billboards. City Attorney Cirullo will review the subject and report back to the City Commission.

Commissioner Gordon reported that Wednesday, December 7th is Lighthouse A'Glow, and encouraged everyone to attend at Frank McDonough Park from 6:30 p.m. - 8:30 p.m.
