AN ORDINANCE CHANGING AND AMENDING THE COMPREHENSIVE ZONING ORDINANCE NO. 1979 (42) OF THE CITY OF PETAL, MISSISSIPPI, AS AMENDED BY ORDINANCE NUMBERS 1979 (42-1) THROUGH 1979 (42-4416) SO AS TO CHANGE THE ZONING CLASSIFICATION OF PROPERTY LOCATED AT 261 SMITHVILLE ROAD, FROM R-F (RURAL FRINGE) TO R-2 (LOW-MEDIUM DENSITY RESIDENTIAL)

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL,

MISSISSIPPI:

SECTION 1.
