WHEREAS, child abuse and neglect is a serious problem, and ending abuse involves all people in the community; and

WHEREAS, approximately 3.5 million children are subject to at least one report of abuse and neglect in America. Each year, 17.2% of these children are classified as victims based upon substantiation, and 31,000 of these reports were from the state of Mississippi.

In 2016, Kids Hub Child Advocacy Center provided services to 146 children from Forrest County.

WHEREAS, the effects of child abuse and neglect are felt by whole communities, and need to be addressed by the entire community; and

WHEREAS, Kids Hub Child Advocacy Center is sponsoring events throughout the mont' heighten public awareness of abuse and neglect in our community; and

WHEREAS, these events will provide information and material that supports families to prevent child maltreatment and celebrate people who work with and support children and families; and

WHEREAS, "Pinwheels for Prevention" campaign has been launched through the media, county courthouses and local businesses during the month of April to bring awareness of the need to strengthen families and communities to minimize abuse; and

WHEREAS, effective child abuse prevention programs succeed because of partnerships created among social service agencies, schools, religious and civic organizations, law enforcement agencies, and the business community; and
