ORDINANCE 1979(42-A391)

AN ORDINANCE AMENDING ORDINANCE NUMBER 1979 (42-A354) REMOVING TIME RESTRICTIONS ON POLITICAL SIGNS

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY

OF PETAL, MISSISSIPPI:

SECTION 1: SECTION 7.53.06.10 AMENDED:

SECTION 7.53.06.10 of ORDINANCE 1979(42-A354) is amended to read as follows:

Political signs are to be limited to one sign per candidate per premises not to exceed **sixteen** (16) **square feet**, with the exception of signage placed on outdoor advertising (billboard) signs. No sign shall be permitted on private property without permission of the owner. Signs may be posted **once a candidate officially qualifies for the election**, and must be removed within 10 days after any election to which the sign refers. Placement of political signs shall be limited to the ward or jurisdiction in which the candidate is qualified to run for election.

SECTION II.

Ordinance 1979 (42-A354) as adopted by the Mayor and Board of Aldermen of the City of Petal except as amended be in full force and effect.

The above and foregoing amendments to the Ordinance shall take effect and be in force within 30 days of passage.
