

PLANNING AND CONSULTING SERVICES

THIS AGREEMENT is entered into by and between **SLAUGHTER & ASSOCIATES**, **PLLC**, hereinafter called the CONSULTANT and the **CITY OF PETAL**, **MISSISSIPPI**, hereinafter called the CITY.

- 1. The CITY does hereby employ the CONSULTANT to perform professional and technical services for: **PLANNING STUDY**.
- 2. The CONSULTANT hereby agrees to perform the above services in a diligent and competent manner in accordance with the standards applicable to this work.
- 3. The CITY shall compensate the CONSULTANT for professional services rendered plus direct reimbursement for out-of-pocket expenses including purchased information and services, copies, graphic materials, travel and other necessary expenses. The CONSULTANT may require the assistance of the city engineer regarding water, sewer, street and drainage facilities and cost estimates, whose fee, if any, is not covered in this agreement.
- 4. The CONSULTANT will submit monthly or periodic invoices to the CITY requesting payment. Such requests will be based upon the amount and value of work and services performed by the CONSULTANT and will be accompanied by an itemized statement of work performed. The CITY shall pay the CONSULTANT the total amount of the invoice within thirty (30) days after receipt of the invoice. Nonpayment or payment less than the amount of the invoice within the specified time shall be cause for suspension of work by the CONSULTANT. The invoices will be based on the following rate schedule:

Principal Planner: \$150/hr.
Associate Planner I: \$125/hr.
Associate Planner II: \$100/hr.
Assistant Planner I: \$85/hr.
Assistant Planner II: \$75/hr.
Planning/GIS Technician: \$60/hr.
Office Technician: \$40/hr.

- 5. The CITY may terminate this letter of agreement at any time with a telephone call and follow-up written notification to the CONSULTANT.
- 6. Any reports, information, data, memoranda, or documents in any form, electronic or otherwise, prepared or assembled by the CONSULTANT under this agreement shall be the property of the CITY, even if remaining with the CONSULTANT, and the CONSULTANT shall maintain confidential all of such information unless specifically authorized in writing by the CITY through its Mayor or Attorney.

LEASE AGREEMENT

WHEREAS, the Mayor and Board of Aldermen of the City of Petal, Mississippi, do hereby find, adjudicate, and determine that the reasonable rental for the Pro Shop at the Petal Skate Park would be the sum of two hundred dollars (\$200.00) per month, and whereas, MATTHEW HOLIFIELD wishes to lease and to rent the Pro Shop at the Petal Skate Park and to pay to the City of Petal the sum of two hundred dollars (\$200,00) per month, it is, therefore, agreed as follows, to wit:

That the City of Petal will lease and let unto Matthew Holifield, the Pro Shop located at the Petal Skate Park, for a period of six (6) months, beginning on the _lst_ day of $_$ June $_$, A_aD_a , 2015, and extending until the $_$ 30th $_$ day of $__$ November $_$, 2015.

That during the term of this lease, adequate consideration will be paid by Matthew Holifield in the amount of two hundred dollars (\$200.00) per month, which sum shall be due and payable to the City of Petal on or before the 1st day of each month, for the next preceding month's rentals.

The City of Petal will cause to be furnished the utilities at the Pro Shop at the Petal Skate Park, at no charge to the Lessee, Matthew Holifield.

The City of Petal reserves the right to terminate the lease with Matthew Holifield, upon any grounds that it finds to be appropriate, by giving to Matthew Holifield, thirty (30) days written notice of its intention to cancel the lease.

For any legal notices required by this Lease Agreement, the following individuals and addresses will be appropriate:

During the term and pendency of this Lease Agreement, the Lessee, Matthew Holifield, will cause to have in effect, a policy of liability insurance indemnifying both Matthew Holifield and the City of Petal, a Municipal Corporation, from any claim, action or injury alleged to have been sustained on the premises of the Pro Shop at the Petal Skate Park. The City of Petal, Mississippi, will be named as an additional insured in said policy of liability insurance.

As part of this Lease Agreement, the Lessee, Matthew Holifield, agrees to the following stipulations from the City of Petal: (1) That he, Matthew Holifield, will make no changes to, or allow any changes to the Skate Park that are not approved by the City of Petal; (2) That he, Matthew Holifield, will not charge a fee to enter the park with the exception of approved competition/events: (3) That he, Matthew Holifield, will get approval from the City of Petal before conducting any competition/events; (4) That he. Matthew Holifield, will open and close the Skate Park if business hours do not coincide with the Recreation Department schedule; (5) That he, Matthew Holifield, will immediately inform the City of Petal Recreation Department and/or City of Petal Police Department of all accidents/incidents that take place in and around the Skate Park.

It is contemplated that this Lease Agreement may be renewed from time to time. upon such terms and conditions as the parties find agreeable.

Safe Harbor for Salarled Exempt Employees with Improper Deductions from Salarles

The City of Petal may compensate certain exempt executive, administrative, professional, and computer employees on a guaranteed salary basis. Deductions from these salaries may only be made when the employee absents himself/herself for personal reasons, for sickness when his/her bona-fide sick leave plan has been exhausted, for disciplinary reasons for infractions of major safety or conduct rules, or in initial or terminal weeks. It is the policy of the City to not make any improper salary deductions based on variations in quantity or quality of work done. Any salaried exempt employee who believes that an improper deduction was made from his/her salary may file a written complaint with the City Clerk over such deduction. The City Clerk will conduct an investigation into the deduction to determine if it was improper. If it is found that the deduction was improper, the amount of the deduction will be reimbursed to the employee by no later than the next pay day, and the City will ensure that such deduction is not made in the future from any exempt employee's salary. There will be no retaliation against the employee for filing a complaint under this section.

All salaried employees of the City of Petal are paid salaries that are intended to cover all hours that are worked.

The City of Petal will pay proper overtime in either cash or compensatory time at its discretion.

AN ORDINANCE CHANGING AND AMENDING THE COMPREHENSIVE ZONING ORDINANCE NO. 1979 (42) OF THE CITY OF PETAL, MISSISSIPPI, AS AMENDED BY ORDINANCE NUMBERS 1979 (42-1) THROUGH 1979 (42-A394) SO AS TO CHANGE THE ZONING CLASSIFICATION OF PROPERTY LOCATED AT 119 W.
