COMPLETE AUTOMOTIVE, LLC, will cause to have in effect, a policy of liability insurance indemnifying both COMPLETE AUTOMOTIVE, LLC and the City of Petal, a Municipal Corporation, from any claim, action or injury alleged to have been sustained on the premises of 144 West Central Avenue. The City of Petal, Mississippi,

will be named as an additional insured in said policy of liability insurance.

As part of this Lease Agreement, the Lessee, COMPLETE AUTOMOTIVE, LLC, (a) shall be allowed by the City of Petal to make changes and improvements to the property at 144 West Central Avenue that he deems necessary for the function of his business, (b) Minor repairs and routine maintenance of the property at 144 West Central Avenue shall be the sole responsibility of the Lessee. COMPLETE AUTOMOTIVE, LLC, (c) Structural maintenance to the buildings and major repairs shall be the responsibility of the City of Petal.
