**AN ORDINANCE CHANGING AND AMENDING THE COMPREHENSIVE ZONING
ORDINANCE NO. 1979 (42) OF THE CITY OF PETAL, MISSISSIPPI, AS AMENDED BY
ORDINANCE NUMBERS 1979 (42-1) THROUGH 1979 (42-A403) SO AS TO CHANGE THE
ZONING CLASSIFICATION OF PROPERTY LOCATED AT 100 WILSON DRIVE FROM R-2
(LOW-MEDIUM DENSITY RESIDENTIAL) TO
C-O (COMMERCIAL OFFICE DISTRICT)**

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL,

SECTION 1.
