### ORDINANCE 2007 (4-2)

AN ORDINANCE CHANGING AND AMENDING THE WRECKER SERVICE POLICY IN THE CITY OF PETAL

### BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF

#### THE CITY OF PETAL, MISSISSIPPI:

SECTION 1. Section 13 of Ordinance 2007 (4) is hereby amended as follows:

#### Section 13. Suspension, revocation, or denial of registration permit.

- Any registration permit issued under the provisions of this article may be suspended or revoked, or the issuance of such permit denied by the Chief of Police or the Assistant Chief of Police, upon reasonable proof of violation by the operator or employees of a wrecker/towing service of any of the previously adopted sections of this ordinance, with the addition of the following:
  - Conduct of practices in dealing with the public that result, or can result, in unjust criticism to the City of Petal or its employees;
  - Other circumstances or actions involving the owner/operator or employees that discredit the City of Petal or its employees. 2.

#### SECTION II. Maximum Rate Schedule Established

- A. Rates for standard or non-standard rotation wrecker tow include the following:

  - Response to the call
     Any special equipment needed
     Clean-up of the scene
     Retrieval of the vehicle from the impound lot
     Fuel
- B. Rates are as follows:

  - Standard tow maximum \$150,00 (includes 15 minutes for hook-up)
     Second wrecker maximum \$100,00
     Additional time rate (each 15 minutes/not to include travel time back to wrecker yard) \$25,00

SECTION III. The above and foregoing amendment to Ordinance 2007(4), shall take effect and be in force within thirty (30) days of today's date.

SECTION IV. Except as amended herein, Ordinance 2007 (4) and Ordinance 2007 (4-1) in full force and effect.
