RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI, DECLARING THE RESULT OF AN ELECTION DULY CALLED AND HELD ON THE FIRST DAY OF APRIL, 1975, TO ASCERTAIN THE WILL OF THE QUALIFIED ELECTORS OF THE CITY OF PETAL, MISSISSIPPI, TOUCHING UPON THEIR APPROVAL OF A CERTAIN ORDINANCE PASSED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI ON THE FOURTH DAY OF MARCH, 1975, ENTITLED "AN ORDINANCE GRANTING AN ELECTRIC FRANCHISE TO MISSISSIPPI POWER COMPANY, ITS SUCCESSORS AND ASSIGNS, IN THE CITY OF PETAL, MISSISSIPPI."

BE IT RESOLVED, by the Mayor and Board of Aldermen of the City of Petal, Forrest County, Mississippi:

- 1. That on the 4th day of March, 1975, at the regular meeting of the Mayor and Board of Aldermen of the City of Petal, Mississippi, an ordinance was duly adopted by said Mayor and Board of Aldermen entitled "An Ordinance Granting An Electric Franchise to Mississippi Power Company, Its Successors And Assigns, In The City Of Petal, Mississippi."
- 2. That it was provided in Section 13 thereof that such ordinance should take effect and be in force from and after its passage by the Mayor and Board of Aldermen and ratification by a majority of the qualified electors of the City of Petal, Mississippi, at a special election to be called and held for such purposes and its due and legal publication according to law.
- 3. That such ordinance was duly passed by the Mayor and Board of Aldermen and has been duly published in the Hattiesburg American, a newspaper having general circulation in the City of Petal, Mississippi, on the 6th day of March, 1975, and proof of such publication has been duly made and filed with the Clerk of the City of Petal, Mississippi, and is now on file in the proper office of the City of Petal, Mississippi.

| 4. That the Mayor and Board of Aldermen on the 4th day of March, |

| circulation in the City of Petal, Mississippi, and proof of publication thereof |
| has been duly made and filed with the Clerk of the City of Petal, Mississippi, |
| and now is on file in the proper office of the City of Petal, Mississippi. |

- 5. That in said election 1152 qualified electors voted of which 1019 voted for the approval of said ordinance and 133 voted against the approval of said ordinance, and that a majority of the qualified electors approved said ordinance.
- 6. That all things legal, necessary and proper for the holding of such special election to ascertain the will of the qualified electors of the City of Petal, Mississippi, as to the approval or disapproval of said ordinance have been done and performed according to law and that such ordinance entitled "An Ordinance Granting An Electric Franchise to Mississippi Power Company, Its Successors And Assigns, In The City Of Petal, Mississippi" has been duly approved and ratified by a majority of the qualified electors of the City of Petal, Mississippi, and is now in full force and effect as an ordinance of the City of Petal, Mississippi.

The within and foregoing Resolution was reduced to writing, read and considered by sections at a regular meeting of the Mayor and Board of Aldermen of the City of Petal, Mississippi, on this <u>1st</u> day of April, 1975, and upon motion of Alderman <u>W. H. Clearman</u>, duly seconded by Alderman <u>Mitchell Curry</u>, that the foregoing Resolution be adopted, a final yea and nay vote was taken, which resulted as follows:
