ORDINANCE 1975 (25)

AN ORDINANCE CREATING REQUIREMENTS FOR THE ISSUANCE OF ELECTRICAL LICENSES, CREATION OF AN ELECTRICAL EXAMINING BOARD AND A BOARD OF REVIEW, PROVIDING PENALTIES FOR VIOLATIONS THEREOF, DISCLAIMER OF LIABILITY FOR DAMAGE BY THE CITY AND FOR RELATED PURPOSES.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION 1.

Before any person may perform or do any electrical work within the City of Petal, Mississippi, they must apply for and receive an Electrical License and pay the fee herein required.

Before any Electrical License may be issued, the applicant shall meet the following requirements:

Part 1. All applicants must be at least 21 years of age.

Part 2. An applicant for a Master's License shall have had at least five (5) years experience as an electrician or he shall be a graduate of a trade school or technical school or college of recognized standing, and in addition, shall have had one (1) year of practical experience as an electrician and he must also furnish three (3) letters from reputable businessmen attesting to the applicant's experience and character. The applicant must have a telephone for the purpose of receiving any directions from the building inspector or the electrical inspector of the City of Petal.

Part 3. An applicant for a Journeyman's License must have had at least four (4) years experience under the supervision of a Master or Journeyman Electrician or have had its equivalent in the opinion of the Electrical Examining Board or be a graduate of any trade or technical school or college of recognized standing.

Part 4. An applicant shall be required to successfully pass an examination to be administered by the Building Department by the City of Petal, attaining a minimun score of 70.

ESTABLISHMENT OF A BOARD OF ELECTRICAL EXAMINERS

Part 1. A Board of Electrical Examiners is hereby established, to consist of six (6) members to be appointed by the Mayor and Board of Aldermen, to-wit:

- The City Electrical Inspector, or Building Inspector, who shall be a permanent adivosry, <u>ex officio</u> and nonvoting member of the Board.
- (2) An accredited electrical engineer, architect, draftsman, holding a Certificate of Registration in the State of Mississippi.
- (3) Two electrical contractors holding Master's Licenses as provided by this Ordinance.
- (4) Two representatives at large, having technical training and experience.

The Chairman of the Board shall be elected by the five voting members.

The initial term for the engineer, architect, or draftsman, one electrical contractor and one representative at large shall be for one year. The initial terms for the other electrical contractor and the other representative at large shall be for a period of two years.

All appointments thereafter shall be for a period of two years. All vacancies in said Board, because of resignation, death, or removal prior to the expiration of the term of such member shall be filled by appointment at the next meeting of the Mayor and Board of Aldermen. The Board shall serve without pay.

Part 2. The Electrical Examining Board shall have the following duties:

(1) It shall be the duty of the Electrical Examining

Board to receive all applications from electricians seeking to enter upon or continue in the business of electrical contracting within the City;

(2) To compose the qualifying examination and prescribe the conditions thereof;

(3) To give the examination to all persons who are, under the provisions of this Ordinance, required to take such examination;

(4) To authorize the issuance of the license applied for upon qualification of such applicant, and payment of a ten (\$10.00) dollar fee for the issuance of said license to the City Building Department;

(5) To prescribe the conditions under which said license may be continued;

(6) To formulate rules to govern its actions and to take testimony and proof concerning all matters

AN ORDINANCE ESTABLISHING STANDARDS FOR THE INSTALLATION OF ELECTRICAL EQUIPMENT, STAN-DARDS FOR ELECTRICAL EQUIPMENT, PROVIDING FOR THE ISSUANCE OF PERMITS, PROVIDING FEES FOR PERMITS AND INSPECTIONS, AND PROVIDING FOR PENALTIES FOR VIOLATION OF THE ORDINANCE. BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION 1.

STANDARDS FOR THE INSTALLATION OF ELECTRICAL EQUIPMENT

Part 1. All installations of electrical equipment shall be reasonably safe to persons and property and in conformity with the provisions of the National Electrical Code, with amendments thereto, and the applicable statutes of the State of Mississippi, and all orders, rules and regulations issued by authority thereof.

Part 2. Conformity of installation of electrical equipment with applicable regulations set forth in the National Electrical Code, with amendments, which have been approved by the American Standards Association, shall be <u>prima facie</u> evidence that such installations are reasonably safe to persons and property.

The Electrical or Building Inspector may, with the approval of the Mayor and Board of Aldermen, authorize installations of special wiring methods.

Part 1. No electrical equipment shall be installed within or on any building, structure, or premises, publicly or privately owned, nor shall any alteration or addition be made in any such existing equipment without first securing a permit therefor from the Building Department of the City of Petal, Mississippi, except as follows:

> Minor repair work, the replacement of lamps or the connection of portable electrical equipment to suitable permanently installed receptacles;
> The installation, alteration, or repair of electrical equipment for the operation of signals or the transmission of intelligence;

> (3) The installation, alteration, or repair of electrical equipment installed by or for an electricity supply agency for the use of such agency and the generation, transmission, distribution, or metering of electricity.

(4) Any work involved in the manufacturing, testing, servicing, altering, or repairing of electrical equipment or apparatus, except that this exemption shall not include any permanent wiring other than that required for testing purposes;

(5) Installation to use by electricity supply or communication agencies in the generation, transmission or distribution of electricity or for the operation of signals or the transmission of intelligence, and located within or on buildings or premises used exclusively by such an agency or on public thoroughfares;

(6) The installation of equipment employed by an electric or a railway utility in the exercise of its functions as a utility, and located outdoors

or in buildings used exclusively for that purpose; (7) Any person, firm, corporation or institution who conducts all of the work of installation, maintenance and operation of electrical equipment, as herein defined, by and through its own employees and all of whose work of installation, maintenance and operation of such electrical equipment is done in accordance with the standards of the National Electric Code, with amendments, and under the supervision of and inspected by a graduate Electrical Engineer in the full time employ of such person, firm or corporation.

Part 2. Application for such permit, described in the work to be done, shall be made in writing to the Building or Electrical Inspector, by the person, firm or corporation installing the work. This application shall be accompanied by such plans, specifications, and schedules as may be necessary to determine whether the installation as described will be in conformity with the requirements of the National Electric Code, with amendments, being approved and adopted as the Electrical Code for the City of Petal by Ordinance Number 1975 (20). If it shall be found that the installation as described will conform will all legal requirements and if the applicant has complied with all provisions of the said Ordinance 1975-(20), a permit for such installation shall be issued.

No deviation may be made from the installation described in the permit without written approval of the Building or Electrical Inspector of the City of Petal, Mississippi.

DUTIES OF THE PERSON, FIRM, OR CORPORATION AFTER COMPLETION OF ANY INSTALLATION OF ELECTRICAL EQUIPMENT

Upon completion of any installation of electrical equipment

which has been made under a permit, it shall be the duty of the person, firm, or corporation making installation to notify the Building or Electric Inspector, who shall inspect the installation within forty-eight (48) hours, exclusive of Saturdays, Sundays, and legal holidays, of the time such notice is given, or as soon thereafter as is practical under the circumstances.

Part 1. Where the Electrical or Building Inspector finds the installation to be in conformity with the provisions of the National Electric Code, Ordinance 1975-(20) and amendments, he shall issue to the person, firm or corporation making the installation a Certificate of Approval, with duplicate copy for the delivery to the owner, authorizing the use of the installation and connection to the supply of electricity and shall sign written notice of such authorization to the agency supplying the electrical service.

Part 2. When a Certificate of Approval is issued authorizing the connection and use of temporary installations, such Certificate shall be issued to expire at a time to be stated therein and shall be irrevocable by the Building or Electrical Inspector for cause.

Part 3. A Preliminary Certificate of Approval may be issued authorizing the connection and use of certain specific portions of an incompleted installation; such Certificate shall be revocable at the discretion of the Building or Electrical Inspector.

Part 4. When any electrical equipment has to be hidden from view by the permanent placement of parts of the building, the person, firm or corporation installing the equipment shall notify the Building or Electrical Inspector and such equipment shall not be concealed until it has been inspected and approved by the Building or Electrical Inspector, or until forty-eight (48) hours, exclusive of Saturdays, Sundays, and legal holidays, shall have elapsed from the time of such notification; provided that on large installations, where the concealment of equipment proceeds continuously, the person, firm, or corporation installing the electrical equipment shall give the Electrical Inspector due notice and inspection shall be made periodically during the progress of the work.

Part 5. Additional inspections, or inspection trips, made necessary through the failure of an Electrical Contractor to specify location of installation, or failure to install electrical equipment properly, or to otherwise create conditions making such additional inspections or trips necessary, are hereby designated "extra electrical inspections." For each such "extra and paid by said Contractor to the City of Petal, Mississippi.

Part 6. At regular intervals, the Building or Electrical Inspector shall visit all premises where work is being done and shall inspect all electrical equipment installed pursuant to the issuance of a permit by the City of Petal, since the date of his last previous inspection, and if requested, shall issue a Certificate of Approval for such work as if found to be in conformity with the provisions of the National Electric Code, with amendments, Ordinance 1975-(20) after the fees contained in Section 4 have been paid.

Part 7. Routine inspection at the request of individual residential property owners shall be made by the Building or Electrical Inspector after such residential property owner has obtained a permit and paid the appropriate fee to work on his own residential premises.

Part 8. If upon inspection, the installation is not found to be fully in conformity with the provisions of the National Electric Code, with amendments, Ordinance 1975-(20), the Building or Electrical Inspector shall at once forward to the person, firm, or corporation making installation a written notice stating the defects which have been found to exist.

Part 9. It shall be unlawful for any person, firm, or corporation to make connection from a supply of electricity or to supply electricity to any electrical equipment for the installation of which a permit is required or which has been disconnected or ordered to be disconnected by the Building or Electrical Inspector, until such connection has been authorized by the Building or Electrical Inspector.
