After reading of this bids, Mayor Byrd appointed Mr. Curry and Mr. Clearman to take these bids under advisement and make a decision as to which bid would be of the best and lowest price. Mayor Byrd stated that at the next council meeting a decision would be made.

WHEREAS, the hour of 7:30 P.M., having arrived, being of the time that the Mayor and Board of Aldermen were to read all bids received for the purchase of 24,000 gallons of gasoline.

The Board finds that there were no bids received for the Notice to Bidders of 24,000 gallons of gasoline.

THEREUPON, Mr. Tyner addressed the Mayor and Board of Aldermen stating that since no bids were received for gasoline that Mrs. Smith should get in contact with three (3) gasoline suppliers and obtain three (3) written proposals for 24,000 gallons of gasoline to be supplied to the City of Petal at the rate of 2,000 gallons per month for one (1) year.

THEREUPON, after a lengthy discussion, Mayor Byrd stated that Mrs. Smith would have the proposals by the end of the week.

Mayor Byrd addressed the Board of Aldermen stating that the Mississippi State Highway Department was desirous of entering into a contract with the City of Petal in order that the City may utilize urban funds under the Federal Aid Highway Act of 1973. Mayor Byrd stated that under this contract 70% of the funding would be furnished by the state and 30% would be funded by the City of Petal. Mayor Byrd stated that the 30%

funding by the City of Petal could be worked out by an in-kind service provided by the City of Petal. Mayor

Byrd stated that this contract would be of great benefit to the City of Petal.

THEREUPON, Thomas W. Tyner presented the following resolution, to-wit:

RESOLUTION

WHEREAS, the City of Petal is desirous to construct, reconstruct, and/or

improve traffic services on certain City streets; and

WHEREAS, under the Federal Highway Administration Act of 1973, Subsection (D), Section 103, Title 23, United Stated Code, the City of Petal could receive Urban Systems funds to enable the City of Petal's financial participation in such projects; and WHEREAS, in order for the City of Petal to participate in such projects, the City of Petal shall enter into contract with the Mississippi State Highway Commission; and WHEREAS, when the City of Petal enters into such contract with the Mississippi

State Highway Commission, it will enable participation in the Urban System Program; and

funding for the aforesaid project on a 70 per cent federal - 30 per cent city funding ratio; and,

WHEREAS, the Mayor and Board of Aldermen deem it necessary for the best interest of the public health and welfare to enter into a contract with the Mississippi State Highway Commission;

NOW, THEREFORE, BE IT RESOLVED by the Board of Aldermen that the Mayor and City Clerk are hereby authorized to sign a contract with the Mississippi State Highway Commission for participation in the Federal Aid Urban System Program.

WHEREAS, that certain area of Forrest County, Mississippi, east and north of the Leaf River in said county has been considered as a part of the Petal School System, and;

WHEREAS, it is found to be in the best interest of the City of Petal, its citi-

zens, and those citizens of Forrest County residing east and north or the Leaf River to be a part of a separate school system;
