WHEREAS, the City of Petal, Mississippi, and the Board of Supervisors of Forrest County, Mississippi, did heretofore enter into a similar agreement in 1974 and since that time the Forrest County Board of Supervisors, particularly Supervisors District No.2 and Supervisors District No.3, have not only maintained the roads in accordance with said agreement but have done all work in connection with ditching, drainage, placing and replacing of culverts, collection of trash, garbage collection and spraying for mosquitoes, and

WHEREAS, Forrest County Board of Supervisors have done this work in a spirit of cooperation in its desire to help the City of Petal, Mississippi, which is Mississippi's newest incorporated municipality, until revenues and tax collections in the City of Petal would permit the assumption of some of such work by the City, and
