WHEREAS, the Mayor and Board of Aldermen of the City of Petal, Mississippi, find and adjudicate that it would be in the public interest and in the best interest of the City of Petal, Mississippi, for said City to own and operate the water and sewage system presently owned and operated by the East Forrest Utility District:

Section 1, A local and private bill is hereby requested to authorize the East Forrest Utility District to transfer, assign, and convey all of its assets and liabilities to the City of Petal, Mississippi.

Section 2, That the members of the Mississippi State Legislature representing Forrest County, Mississippi, be, and they are hereby requested to secure the necessary legislative authority in the premises.

WHEREAS, Mayor Byrd recognized Mr. T. G. Watson, Superintendent of Delivery and Collection and Mr. J. O. Lamousin, Officer in charge of the Meridian Postal Sectional Center.

THEREUPON, Mr. Watson addressed the Mayor and Board of Aldermen stating that he was representing the Meridian Postal Sectional Center with recommendations of a survey for the Petal Postal operations. Mr. Watson stated that this survey was routine in instances of Postmaster vacancies. These recommendations would result in an adminstrative adjustment to the management structure of the Petal Post Office. This adjustment would classify the Petal Post Office as a classified branch of Hattiesburg. Mr. Watson stated that the results of the survey would provide an equivalent level of service, more efficient management thru a larger and more versatile staff, and would also move three (3) rural routes from Hattiesburg to Petal. Mr. Watson said there would be no personnel changes, no changes of addresses, Zip Code, or postmark.

After a lengthy discussion it was determined that the recommended survey had already been initiated and recommendations have been made without the approval or notification of the city adminstration or the Citizens of Petal.

WHEREAS, Mayor Byrd recognized Mr. Vince Howard, consulting Engineer with Hensley-Schmidt, Inc.

Mr. Howard addressed the Mayor and Board of Aldermen concerning the resolution between the City of Petal and the Federal Highway Administration. Mr. Howard stated that the resolution should be approved before the final Federal Aid Systems can be established.


