ORDINANCE 1977 (34)

AN ORDINANCE PROVIDING FOR THE METHOD OF ELECTION OF THE FIVE (5) ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI, BY PROVIDING THAT FOUR (4) ALDERMEN BE SELECTED FROM EACH OF THE FOUR (4) WARDS, ONE (1) ALDERMAN SELECTED FROM THE MUNICIPALITY AT LARGE, SAID ALDERMEN TO QUALIFY AND BE ELECTED BY POSTS, AND FURTHER PROVIDING THAT ALL ALDERMEN BE ELECTED BY MAJORITY VOTE OF THE ENTIRE ELECTORATE OF THE MUNICIPALITY.

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Petal, Mississippi, as follows, to-wit:

Section 1. The five (5) Aldermen of the Qity of Petal, Mississippi, shall be selected, one (1) Alderman from each of the four (4) wards of the municipality, and one (1) Alderman to be selected at large, all Aldermen to qualify and be elected by Post.

Section 2. The five (5) said Aldermen of the City of Petal, Mississippi, be, and the same are hereby designated as follows: Post No. 1, to be a resident of Ward 1; Post No. 2 to be a resident of Ward 2;, Post No. 3 to be a resident of Ward 3; Post No. 4 to be a resident of Ward 4; and Post No. 5 to be a resident of the municipality. Any candidate for the office of Aldermen in any special, primary, or general election shall announce and qualify for the specific Post which he seeks to occupy. Ballots for all elections of Aldermen shall be prepared so as to designate the candidates for each of the five (5) Posts, and all the electors of the municipality may vote for the candidates of their choice for each of said five (5) Posts, one candidate for each Post to be selected by majority vote of the entire electorate of the municipality.

Section 3. This Ordinance shall become operative and be in full force and effect, within thirty (30) days, subject to any objections from the Attorney General of the United States, or the Attorney General of the State of Mississippi, pursuant to the Voting Rights Act of 1965, 42 U.S.C. 1973 (c).
