WHEREAS, Mr. Tyner reported to the Board concerning the City of Petal Ordinance 1977 (34) which was submitted to the U. S. Department of Justice for the ruling. Mr. Tyner stated that a letter had been written concerning our Ordinance, but due to typographical corrections, the letter will be retyped and submitted to the City of Petal approving the at-large-elections.

Mr. Tyner continued to explain that the Voting Rights Act states that if the

U. S. Department of Justice does not submit a ruling of objection within sixty (60) days, there is automatic approval of such ordinance; the submission has been in the U. S. Department of Justice for more than sixty (60) days. However, the City of Petal in enjoined by an order of the U. S. District for the Northern District of Mississippi, from having at-large-elections and a court injunction is stronger than the directive language of the Voting Rights Act. Mr. Tyner cited other cases that were acted upon in which the clients chose to proceed with at-large-elections without proper approval and they were involved in lengthy court cases. Mr. Tyner stated that the best advise he could give the Board if they desire at-large-elections, would be to wait until a written decision has been received from the U. S. Justice Department. After discussion, the Board agreed to make a decision by the regular meeting of April 5th.
