WHEREAS, Mr. Glenn Grimsley presented a copy of an estimated budget for a proposed teen shelter in Petal. Mr. Grimsley stated that of this \$80,000 budget, approximately \$60,000 would be funded through the Welfare Department Title XX funds, and the other \$20,000 through local sources. Mr. Grimsley stated that these funds would support two shelters for abused and neglected children, one for boys and one for girls. Mr. Grimsley requested that the board consider allocating \$5,000 for this shelter for the budget year 78-79. Mr. Grimsley stated that he would approach the City of Hattiesburg, and the Forrest County Board of Supervisors for the balance of the matching funds.

THEREUPON, Alderman Boutwell made a motion to give Larry Wade and Mr.

Grimsley permission to go to the City of Hattiesburg and the Board of Supervisors with a positive feeling from the City of Petal board of Aldermen asking their support in the establishment of this teen shelter. Alderman Russell seconded the motion.
