That it is necessary and advisable and in the best interest of the Municipality and its inhabitants to issue Combined Water and Sewer System Revenue Bonds of the Municipality in the maximum amount of One Million One Hundred Thousand Dollars, (\$1,000,000.00) to raise money for the following purpose: To improve, repair and extend the combined

water system of the City of Petal, Mississippi.

- 2. That the Governing Body has employed Shows and Dearman of Hattiesburg, Mississippi, a competent engineering firm, to study said system, to determine the nature and extent of the improvements, repairs and extensions, necessary thereto, and make an estimate of the cost thereof;
- 3. That said engineers have determined the nature and extent of the necessary improvements, repairs and extensions to said system and have made an estimate of the cost thereof;
- 4. That said improvements, repairs and extensions are necessary, are economically feasible, and that it would be in the public interest and of benefit to the Municipality that the same be made, and findings of said engineers are hereby adopted, including the estimate of the costs of said improvements.
- 5. That under the provisions of Chapter 494, General Laws of Mississippi, Regular Session 1950, and laws supplementary and amendatory thereto, being also Sections 21-27-11 through 21-27-69, Mississippi Code of 1972, the Municipality is authorized to make such improvements, repairs and extensions and to provide for the payment of the cost thereof, or any portion of such costs, by and through the issuance of bonds;
- 6. That a sum not exceeding One Million One Hundred Thousand Dollars (\$1,100,000.00) must be provided and raised by the issuance of special obligation bonds in said amount, payable both as to principal and interest from the revenues of said system, as authorized by Sections 21-27-11 through 21-27-69, Mississippi Code of 1972; and
- 7. That it is necessary and in the public interest that the Municipality issue said bonds in the maximum principal amount of One Million One Hundred Thousand Dollars (\$1,000,000.00) for the purposes hereinabove stated, for which purposes there are no other available funds on hand, and under the procedures as hereinafter set forth.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI, AS FOLLOWS:

its intention to issue Combined Water and Sewer System Revenue Bonds of the Municipality in the maximum principal amount of One Million One Hundred Thousand Dollars (\$1,100,000.00) to raise money for the following purpose: For improving, repairing and extending the combined water system of the City of Petal, Mississippi.

SECTION 2. That the said bonds in the amount and for the purpose aforesaid will be authorized to be issued at a meeting of the Governing Body to be held at City Hall, Petal,

Mississippi, on Tuesday, September 12, 1978, at 7:30 P. M., which date so fixed will be more than ten (10) days after the third date of publication of this resolution, as directed by Section 3 hereof. If a petition signed by not less than twenty percent (20%) of the qualified electors of the Municipality be filed objecting to and protesting against the issuance of such revenue bond issue on or before the aforesaid date and hour, then an election on the question of the issuance of such bonds shall be called and held as provided by law. If no such protest be filed, then such bonds will be issued without an election on the question of the issuance thereof, and will be sold under the regular procedure for selling such bonds.

SECTION 3. That this resolution shall be published once a week for at least three (3) consecutive weeks in the Hattiesburg American, a newspaper published in the City of Hattiesburg, Forrest County, Mississippi, no newspaper being published in the Municipality, and said newspaper having a general circulation in the Municipality, and in Forrest County, Mississippi, and being a qualified newspaper under the provisions of Section 13-3-31, of the Mississippi Code of 1972, and third such publication to be more than ten (10) days prior to the date specified in Section 2 hereof.

SECTION 4. That the Clerk of the Municipality shall be and she is hereby directed to procure from the publisher of the aforesaid newspaper the customary proof of publication of this resolution and have the same before the Governing Body on the date and hour specified in Section 2 hereof.
