SUBJECT: Federal-Aid Urban System Funds

The attached list details the allocation of Fiscal Year 1978 Federal-Aid Urban Funds to eligible areas within the State. As before, the Commission has limited the use of these funds to construction only to obtain maximum benefits from the available money. Fiscal year 1978 funds allocated to any city not committed to construction of approved projects by June 30, 1979, may be withdrawn at that time.

Effective March 1, 1978, Highway Department policy will require each city to deposit the thirty (30) percent matching portion for each project in the State Highway Fund prior to authorization of the project. Eligible charges, including both city and state construction engineering will be paid from this fund. This is a change from the previous procedures in that the State's construction engineering was not charged to any project.

Attached for your information is a copy of a status report presenting the status of the Urban System Program in your city as of December 31, 1977. This report lists all projects, their estimated cost, total funds available, total funds programmed, and balance available for programming.
