TO THE WATER USERS OF THE EAST FORREST UTILITY DISTRICT, PETAL WATER SYSTEM:

During the January-March grading period, the East Forrest Utility District Petal water system failed to comply with the coliform bacteria standards established by the Safe Drinking Water Act, in that the average coliform density was 25.4 for this period. The maximum allowable under the standards is 1.0 per 100/ml.

During this same period, the system also failed to comply with the Safe Drinking Water Act, in that the percentage of positive samples was 41.0 percent. The maximum allowable under the standards is five percent.


