ORDINANCE 1981 (51)

AN ORDINANCE PROHIBITING THE POSSESSION
OR CONSUMPTION OF ALCOHOLIC BEVERAGES
ON CITY PROPERTY, PROVIDING PENALTIES FOR
VIOLATION THEREOF, AND RELATED PURPOSES

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION 1. Possession or Consumption Prohibited

The possession or consumption of alcoholic beverages on real property owned or occupied by the City of Petal is prohibited.

SECTION 2. Penalties

Any person or persons violating the provisions of this Ordinance shall be guilty of a misdemeanor and upon conviction thereby, shall be fined not more than \$300.00 or imprisoned not to exceed thirty days, or by both said fine and imprisonment.

SECTION 3. Effective Date

The above and foregoing Ordinance shall take effect and be in force thirty days from and after its passage and adoption.

The above and foregoing Ordinance, having been reduced to writing, the same was introduced and read and a vote was taken thereon, first section by section, then upon the Ordinance as a whole with the following results:


