COMES NOW Petal-Harvey Baptist Church and Petitions the Honorable Mayor and Board of Aldermen of the City of Petal, Mississippi, to cancel two tax sales and prorate and reduce the 1986 tax liability due on two parcels of property purchased by Petal-Harvey Baptist Church during 1986, and in support of this position would show as follows:

I.

On May 21, 1986, Petal-Harvey Baptist Church acquired title to a parcel of property by Warranty Deed from Herbert Roger Jenkins, said Warranty Deed being recorded in Land Deed Book 570 at Page 312. The property was assessed for 1986 city taxes as Parcel No. 61102338, and the city ad valorem tax was \$280.19 as shown by City Tax Receipt No. 4277. On April 6, 1987, this parcel was sold by the City of Petal to College Investment for 1986 city taxes as shown by the Tax Sale Records on file in the City Clerk's Office. This parcel is hereinafter referred to as the "Jenkins lot".

II.

On June 5, 1986, Petal-Harvey Baptist Church acquired title to a parcel of property by Warranty Deed from Lewis E. and Jean C. Turner, said Warranty Deed being recorded in Land Deed Book 570 at Page 611. The property was assessed for 1986 city taxes as Parcel No. 63700002, and the city ad valorem tax was \$360.65 as shown by City Tax Receipt No. 6568. On April 6, 1987, this parcel was sold by the City of Petal to George Merritt for 1986 city taxes as shown by the Tax Sale Records on file in the City Clerk's Office. This parcel is hereinafter referred to as the "Turner lot".

III.

Based upon the dates of the instruments conveying title to the two parcels of property, the Jenkins lot was owned by an individual 38.63% of the 1986 tax year and by Petal-Harvey Baptist Church the remainder of the year. Likewise, the Turner lot was owned by individuals 42.74% of the 1986 tax year and by Petal-Harvey Baptist Church the remainder of the tax year.

IV.

Section 27-31-1(d) of the Mississippi Code of 1972, as amended, exempts from taxation the property of any church, including Petal-Harvey Baptist Church, used as a place of worship and not for profit. The above described parcels are located contiguous to the main worship facility of Petal-Harvey Baptist Church and have been used in connection therewith since the date of their acquisitions, and said properties qualify for the exemption provided by law.

٧.

By Order adopted May 4, 1987, the Forrest County Board of Supervisors authorized proration and reduction of 1986 county taxes on the two parcels of property.

VI.

Based upon the information herein contained,
Petal-Harvey Baptist Church requests that the two tax sales
hereinabove referenced be set aside and cancelled, and that
the tax liability on the two parcels of property be prorated
and reduced for the 1986 tax year, and that the City of
Petal Tax Collector be authorized to accept payment as follows:

A. Jenkins lot: \$280.19 x 38.63% = \$108.24 plus interest, penalty and costs related to tax sale

B. Turner lot:

\$360.65 x 42.74% = \$154.14 plus interest, penalty and expense of tax sale
