ORDINANCE NUMBER 1984 (57) B OF THE CITY OF PETAL, MISSISSIPPI

AN ORDINANCE AMENDING SECTION 14 (A) OF ORDINANCE 1984 (57) OF THE CITY OF PETAL, MISSISSIPPI, SO AS TO CHANGE THE CHARGES FOR SEWER USE & TREATMENT WITHIN THE CITY OF PETAL, MISSISSIPPI, REPEALING SECTION 14 (A) OF ORDINANCE NUMBER 1984 (57) AND FOR RELATED PURPOSES.

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Petal, Mississippi:

SECTION 1. Section 14 (A) of Ordinance Number 1984 (57) as originally adopted on May 17, 1984 is hereby amended to read as follows, to-wit:

SECTION 14. (A) The following schedule of rates is hereby ascertained, found and declared to be reasonable, and the same are established as the rates to be charged for water and sewer service furnished on a quanity or meter basis, subject to minimum charges shown below:
