ORDINANCE 1986 (65B)
AN ORDINANCE AMENDING SECTION 4, PARAGRAPH 2
OF ORDINANCE 1986 (65)

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION I. Section 4, paragraph 2 of Ordinance 1986 (65) as passed and adopted on May 6, 1986, be and the same is hereby amended to read as follows:

SECTION 4. BUILDING SEWERS AND CONNECTIONS

2. There shall be two (2) classes of building sewer permits: (a) for residential and commercial service, and (b) for service to establishments producing industrial waste. In either case, the owner or his agent shall make application on a special form furnished by the City. The permit application shall be supplemented by any plans, specifications, and shall meet OSHA requirements, or other information considered pertinent in the judgement of the Superintendent. A permit and inspection fee of One Hundred Eighty Five Dollars (\$185.00) for a residential or commercial building sewer permit and Three Hundred Fifty Dollars (\$350.00) for an industrial building sewer permit shall be paid to the City at the time the application is filed.

SECTION II. All Ordinances in conflict herewith be and the same are hereby repealed.

SECTION III. Ordinance 1986 (65) and Ordinance 1986 (65A) except as amended herein be, and the same are still in full force and effect.

SECTION IV. This Ordinance, amended Ordinance 1986 (65B) based upon urgent necessity and circumstances shall be effective immediately.

The above and foregoing Ordinance having been reduced to writing, the same was read and voted upon, first section by section and then as a whole.

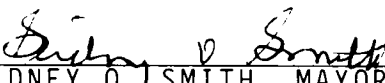
