ORDINANCE 1979(44-B)

AN ORDINANCE TO AMEND ORDINANCE NUMBER 1979 (44-A) INCREASING THE SERVICE FEE FOR THE COLLECTION AND DISPOSAL OF GARBAGE

SECTION 1: Section A of Ordinance 1979 (44-A) is hereby amended to read as follows:

Section: A. The following monthly fees are established for the collection removal, or disposal of garbage:

- a. For each residence within the City of Petal, the sum of Three dollars (\$3.00) per month;
- b. For apartment complexes, of more than two (2) units provided the garbage is maintained and can be collected at one collection place, the sum of One Dollar & fifty cents (\$1.50) per apartment, per month;
- c. For all duplexes, two (2) apartment units, the sum of Three Dollars (\$3.00), per apartment, per month:
- d. For mobile home parks, provided all the garbage is maintained and can be collected in one collection place, the sum of One Dollar & fifty cents (\$1.50) per mobile home unit:
- e. For all other garbage collection customers, the sum of Three Dollars (\$3.00) per month, provided a garbage pickup is not required to be made more than twice in any one week;
- f. For other collection services, requiring special handling, or more than two (2) collections per week, a fee to be determined by application of Section 1-12 of Ordinance 1979 (44).

SECTION 2. That except as otherwise amended herein, Ordinance 1979 (44) and 1979 (44-A) shall remain in full force and effect.
