

WHEREAS, MAYOR GAY STATED THAT THE UNSAFE AND SANITARY CONDITIONS AT THE PROPERTY OF CARL E AND VIRGINIA M ORR ON RAILROAD STREET HAS BEEN BROUGHT TO THE ATTENTION OF THE BOARD AND AFTER PROPER NOTICE TO THE PROPERTY OWNERS THE HEARING HAS BEEN CALLED. THE PROPERTY BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

THEREUPON, HAL LEWIS, JR. STATED THAT HE ACTUALLY OWNS THE AFOREMENTIONED PROPERTY AND THAT HE HAS MADE SOME IMPROVEMENTS ON THE PROPERTY TO INSURE THE SAFETY OF THE PROPERTY BUT THAT DUE TO FLOODS HE IS NOT SURE THAT HE IS GOING TO INVEST ANY MORE TIME OR MONEY IN THIS PROPERTY.
