WRITTEN PROCEDUE FOR PUBLIC ACCESS TO MUNICIPAL COURT RECORDS

Petal Municipal Court public records will be open for public inspection during regular office hours, Monday thru Priday (except legal holidays) between the hours of 8:00 A.M. and 5:00 P.M. Dockets use by Municipal Court personnel will be used by the public during employees breaks and lunch breaks to avoid conflict of regular business of Municipal Court.

Request for information will be delivered to the Municipal Court clerk, in writing, stating in DETAIL the information or records requested. If the request for records is denied, denial will be made in writing, stating ressons for the denial. The clerk will have fourteen (14) working days to grant or dany the request. Costs will be paid in advance on the estimated costs of time, materials and copies, any difference will be paid before the records are given to the person making the request.

Costs will be calculated at \$8.00 per hour for personnel to search document ords, in addition to any actual cost of materials, postage, or copies. Copies will be charged at 250 each (or the current rate charged by the Municipal Court).

The public may request records, in writting, and perform records search themselves (during regular hours and not interferring with Municipal Court business) and be charged for only materials and copies at actual cost.

Municipal Court Clerk

Hourly rate will be pro rated on quarter hour at \$2.00 per quarter hour.

WRITTEN PROCEDUE FOR PUBLIC ACCESS TO POLICE DEPARTMENT RECORDS

Petal Police Department jublic records will be open for public inspection during regular office hours, Monday thru Friday (except legal holidays) between the hours of 8:00 A.M. and 5:00 P.M. Dockets use by the Police Department personnel will be used by the public during employees breaks and lunch breaks to avoid conflict of regular business of Petal Police Department.

Request for information will be delivered to Petal Police Department, in writting, stating in DETAIL the information or records requested. If the request for records is denied, denial will be made in writing, stating reasons for the denial. The secretary will have fourteen (14) working days to grant or deny the request. Cost will be paid in advance on the estimated costs of time, materials and copies, any difference will be paid before the records are given to the person making the request.

Cost will be calculated at \$8.00 par hour for personnel to search document cords, in addition to any actual cost of materials, postage, or copies. Copies will be charged at 25¢ each (or the current rate charged by the Petal Police Department).

The public may request records, in writing, and perform records search themselves (during regular hours and not interferring with Police Department business) and be charged for only materials and copies at actual cost.

8. APPOINTMENT OF BOARD:

Each of the Parties shall be entitled to one (1) appointment for each twelve percent (12%) increment of the total waste stream generated rounded either up or down to the nearest one twelfth (1/12) increment which percentage of the waste stream shall initially be determined by Pine Belt Regional Solid Waste Master Plan, December, 1990 as prepared by Neel-Schaffer Engineers, Hattiesburg, Mississippi. After the initial appointments to the Board, appointments shall be in the same manner as set forth above and shall be determined using a four (4) year average of actual waste generated and disposed of in the Regional disposal facility said four year average to begin at such time as the Regional disposal facility becomes fully operational.

PRELIMINARY INJUNCTION

On this day, the above cause came on to be heard on the application of the City of Petal, a municipal corporation, for a preliminary injunction and the parties appearing in open court by and through counsel and having presented stipulations and arguments of counsel, the Court does find as follows:

1.

That without provisions for disposal of household garbage, trash and waste the City of Petal would suffer immediate and irreparable injury.

2

That the Defendant/Respondent, Forrest County Board of Supervisors, has previously received and disposed of household garbage, trash and waste delivered to its Barrontown Landfill pursuant to contract.

3.

That there does not presently exist a valid contract or other agreement between the parties for the disposal of household garbage, trash and waste.

IT IS THEREFORE the order and judgment of the Court that the Defendant/Respondent be preliminarily enjoined from refusing to accept from the City of Petal household garbage, trash and waste at the Barrontown Landfill or in the event the Barrontown Landfill is closed or restricted or otherwise limited in its operations the Defendant/Respondent may designate an alternative landfill.

IT IS FURTHER ORDERED AND ADJUDGED that the Plaintiff/Applicant pay to the Defendant/Respondent the sum of \$3,000.00 for disposal services furnished during the month of October, 1991 and that the City of Petal continue to pay to the Forrest County Board of Supervisors the sum of \$3,000.00 per month until further order of the Court.

IT IS FURTHER ORDERED that if the sums paid by the City of Petal to the Forrest County Board of Supervisors pursuant to this order are found to be inappropriate at a final hearing hereon said funds shall be reimbursed, refunded, or otherwise adjusted.

IT IS FINALLY ORDERED that the preliminary injunction shall remain in full force and effect until the further orders of this Court.
