NOTICE OF SPECIAL MEETING

WHEREAS, MAYOR GAY ANNOUNCED THAT THE EFFORTS AT RESOLVING THE CONTROVERSY BETWEEN THE CITY OF PETAL AND FORREST COUNTY CONCERNING THE \$3,000. PER MONTH FEE FOR GARBAGE DISPOSAL HAS NOT BEEN SUCCESSFUL.

THE MAYOR FURTHER ADVISED THAT THE INTENTION OF THE SUPERVISORS IS TO PROHIBIT THE DISPOSAL AND BURIAL OF THE CITY'S GARBAGE AT THE BARRONTOWN LANDFILL EFFECTIVE FRIDAY NOVEMBER 1, 1991 AND REQUESTED THE WISHES OF THE BOARD.

THEREUPON, ALDERMAN CROWE MADE A MOTION TO AUTHORIZE THE MAYOR AND CITY ATTORNEY TO INITIATE A LEGAL ACTION IN THE CHANCERY COURT OF FORREST COUNTY TO OBTAIN A TEMPORARY AND PERMANENT INJUNCTION WHICH WOULD PROHIBIT THE COUNTY FROM REFUSING TO ACCEPT AND DISPOSE OF GARBAGE AND TRASH COLLECTED BY THE CITY OF PETAL. ALDERMAN CLEPPER SECONDED THE MOTION.





- 1) Authorize legal action concerning the disposal of garbage at the Barrontown landfill.








