After reviewing your request concerning a change in policy relating to the disposal of household garbage generated within the City of Petal, the Board has reviewed the matter and has authorized me to convey to you their acceptance of your proposal presented to this Board at its September 19th meeting. It is our understanding that you propose the following: following:

Forrest County will take over the collection and disposal Forrest County Will take over the collection and disposal of household garbage generated within the City of Petal in return for the City of Petal transferring title to Forrest County, Mississippi its garbage collection equip-ment and paying into the county treasury a sum equal to \$10,000.00 per month from fees collected from household residents of the City of Petal, such fees being a charge by the City of Petal for household garbage services.

We would, therefore, undertake your proposal for the sum of \$120,000 annually, based on the current number of house-holds, as opposed to \$180,000 under the proposed new fee schedule.

By our acceptance of your proposal, the Forrest County Board of Supervisors feels that the people of Petal will have a \$60,000 savings during the current fiscal year, which commenced October 1.

Any details that may need to be worked out need to be completed not later than October 15, in order that we might prepare for commencing services on November 1.

I met with Mayor Ed Morgan Friday and discussed with him our I met with Mayor Ed Morgan Friday and discussed with him our meeting with you and the members of the Board of Aldermen of Petal and the proposals made, and our review of your request. Mayor Morgan indicated that with regard to the question of the county burying all garbage, including that within the City of Hattiesburg, that he agreed in principle with such an undertaking, and it was understood that the details of converting to that system will be worked on and ironed out prior to the end of the current fiscal year, to-wit: September 30, 1992.

The Board of Supervisors sincerely believes that working together in this matter, the best interest of all the people of Forrest County will be served, and we look forward to working together in the future.

THIS LETTER IS TO ACKNOWLEDGE AND THANK YOU FOR YOUR CORRESPONDENCE OF OCTOBER 7, 1991, CONCERNING RECENT DISCUSSIONS HAD BETWEEN YOURSELF AND THE FORREST COUNTY BOARD OF SUPERVISORS, AND THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, CONCERNING THE COLLECTION AND DISPOSAL OF GARBAGE WITHIN THE MUNICIPAL LIMITS OF THE CITY OF PETAL.

AFTER REVIEWING YOUR LETTER, IT IS APPARENT THAT WE HAVE FAILED TO APPROPRIATELY COMMUNICATE TO YOU THE CITY'S POSITION ON THE DISPOSAL FEE, AND OUR SUGGESTION THAT THE COUNTY ASSUME THE GARBAGE COLLECTION RESPONSIBILITY WITHIN THE CITY OF PETAL.

NEEDLESS TO SAY, THÉ PROPOSAL WHICH YOU ATTRIBUTE TO US AS Contained in your letter of october 7, 1991, is far from Being Accurate.

TO DATE, THE ONLY OFFICIAL ACTION TAKEN BY THE MAYOR AND BOARD OF ALDERMEN WAS A VOTE NOT TO PAY THE MONTHLY ASSESSMENT OF FORREST COUNTY, FOR THE BURIAL AND DISPOSAL OF THE GARBAGE COLLECTED BY THE CITY OF PETAL. WE EXPLAINED TO YOU AT OUR MEETING, THAT WE FELT IT WAS NOT FAIR TO THE CITIZENS OF PETAL TO PAY THE COUNTY FOR BURYING GARBAGE WHEN THE COUNTY WAS COLLECTING AND BURYING GARBAGE FOR CITIZENS OUTSIDE THE MUNICIPAL LIMITS OF PETAL, AT NO CHARGE. THIS DECISION WAS BASED ON OUR UNDERSTANDING THAT NO SPECIAL TAX OR ASSESSMENT IS LEVIED BY THE COUNTY FOR THE COLLECTION OF GARBAGE OUTSIDE THE MUNICIPALITY, AND THAT NO SPECIAL CHARGE OR LEVY IS IMPOSED UPON COUNTY RESIDENTS FOR THE DISPOSAL OF THE GARBAGE. THE GARBAGE.

CONCERNING THE COLLECTION OF THE GARBAGE, WITHIN THE CITY OF PETAL, WE DID SUGGEST THAT IF THE COUNTY WISHED TO TREAT THOSE FORREST COUNTY CITIZENS LIVING WITHIN THE MUNICIPAL LIMITS OF PETAL, THE SAME AS IT WAS TREATING THOSE FORREST COUNTY CITIZENS LIVING OUTSIDE THE CITY OF PETAL, IT WOULD NOT ONLY DISPOSE OF THE GARBAGE FOR NO CHARGE, BUT WOULD ALSO COLLECT THE SAME. IT HARDLY SEEMS FAIR THAT ONE SEGMENT OF YOUR CONSTITUENCY RECEIVES A FREE SERVICE, WITHOUT YOUR OFFERING TO PROVIDE THAT SAME FREE SERVICE TO ALL OF YOUR CONSTITUENCY.

THE CITY OF PETAL DID NOT OFFER NOR PROPOSE TO PAY INTO THE COUNTY A SUM OF \$10,000 PER MONTH FOR COLLECTION OF HOUSEHOLD GARBAGE. SUCH A PROPOSAL IS AS BASICALLY UNFAIR AS THE REQUIREMENT THAT PETAL CITIZENS PAY A DISPOSAL FEE WHILE COUNTY CITIZENS ENJOY THAT SERVICE FREE OF CHARGE.

WE SUGGESTED AT OUR RECENT MEETING THAT THE COUNTY TAKE OVER THE COLLECTION OF GARBAGE WITHIN THE PETAL CITY LIMITS, PROVIDING THAT SERVICE TO PETAL RESIDENTS AT THE SAME CHARGE AS WAS PRESENTLY BEING IMPOSED FOR COUNTY RESIDENTS, I.E., NO FEE AND NO SPECIAL TAX LEVY. IN OTHER WORDS, SINCE THE COUNTY IS COLLECTING HOUSEHOLD GARBAGE FOR COUNTY RESIDENTS FREE, WE FELT IT APPROPRIATE THAT THE COUNTY COLLECT THE GARBAGE WITHIN THE CITY AT NO COST OR FEE. THE TREATMENT AND SERVICES PROVIDED TO RESIDENTS OF THE CITY OF PETAL SHOULD NOT DIFFER IN KIND OR CHARACTER FROM THOSE SERVICES PROVIDED TO RESIDENTS WHO LIVE OUTSIDE THE MUNICIPALITY.

TO REITERATE, THE CITY OF PETAL WILL NO LONGER PAY TO FORREST COUNTY, A MONTHLY FEE FOR DISPOSAL OF HOUSEHOLD GARBAGE. THE CITY OF PETAL WILL PERMIT THE COUNTY TO COLLECT HOUSEHOLD GARBAGE WITHIN THE MUNICIPAL LIMITS OF THE CITY OF PETAL, WITHOUT THE IMPOSITION OF A TAX LEVY CHARGE, OR OTHER FEE IN THE SAME WAY THAT THE COUNTY IS NOW COLLECTING HOUSEHOLD GARBAGE OUTSIDE THE CITY.

BY ACCEPTANCE OF OUR PROPOSAL, THE RESIDENTS OF THE CITY WOULD SAVE OVER #200,000 DURING THE CURRENT FISCAL YEAR, AS OPPOSED TO THE PREVIOUS FISCAL YEAR. BY ACCEPTANCE OF OUR PROPOSAL, YOU WILL HAVE RECOGNIZED YOUR DUTY AND OBLIGATION TO PROVIDE TO THE CITIZENS OF THE CITY OF PETAL, THE SAME BENEFITS AND SERVICES AS YOU PROVIDE COUNTY RESIDENTS WHO LIVE OUTSIDE THE CITY. BENEFITS AND SERVICE LIVE OUTSIDE THE CITY.

AS WE HAD PREVIOUSLY INDICATED TO YOU IN CORRESPONDENCE AND MEETINGS, WE ONLY WANT THE COUNTY TO TREAT THE CITIZENS OF THE CITY OF PETAL, WHO ARE ALSO FORREST COUNTY RESIDENTS, THE SAME AS IT TREATS COUNTY RESIDENTS LIVING OUTSIDE MUNICIPALITIES.
