

ORDINANCE 1975(25-A)

AN ORDINANCE CHANGING AND AMENDING THAT CERTAIN ORDINANCE CREATING REQUIREMENTS FOR THE ISSUANCE OF ELECTRICAL LICENSES, AS ADOPTED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL ON JUNE 3, 1975, SO AS TO PERMIT THE ISSUANCE OF AN ELECTRICAL LICENSE TO AN OCCUPANT/HOMEOWNER, ESTABLISHING CONDITIONS THERETO, AND FOR RELATED PURPOSES.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION 1.

That that certain Ordinance 1975(25) adopted by the Mayor and Board of Aldermen of the City of Petal, Mississippi, on June 3, 1975, be and it is hereby amended as follows:

SECTION 1.

Part 5. An applicant, who is also a homeowner and occupant, may apply for an electrical license to perform work on the residence which he owns and occupies, by applying for, taking, and passing a homeowner's/occupant's test, to be promulgated by the City of Petal Board of Electrical Examiners, and administered by the Building Department of the City of Petal, provided a minimum score of seventy (70) is attained.

SECTION 2.

Except as expressly changed and amended, the aforesaid Ordinance 1975(25) shall be and remain in force and form as adopted on June 3, 1975.

SECTION 3.

That this Ordinance take effect and be in full force from and after its passage as provided by law.
