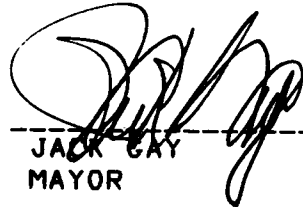

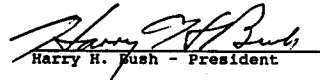

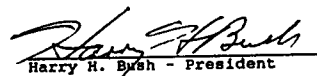

Gentlemen:

I do hereby request that you consider this appeal to the decision made by the Board of Zoning Appeals on June 22 - 29, 1993 regarding my request for a variance.

The facts are as follows:

1. I currently own 96 (+ or -) acres of land situated on Smithville Road, (07/04N/12W) in Petal Mississippi. This land is presently zoned as Rural Fringe property.
2. I am aware that the current ordinances of Petal do not allow a mobile home to be placed in this area.
3. I would like to place a mobile home on my property and allow my son and his wife to reside in said trailer.
4. My son helps extensively with the agricultural activities on my property and it is important that he be located close to the operation.
5. At the present time, my son is unable financially to build a permanent dwelling for his family and I would like to place the trailer until he is able to build for himself.
6. The proposed site for the trailer is well off the public road and in fact is not visible from the road or the only neighboring house.

My appeal is based on the following:

1. I sent my daughter to obtain the application for a variance. She was told by an employee of Petal that I could spend my \$20 but would be wasting the money. Mr. Tolbert was present and agreed.
2. The placement of the variance request sign was misleading as to the placement of the trailer.
3. Only one member of the Board talked to me regarding the placement of the trailer prior to the hearing.
4. The original meeting of the Board of Zoning Appeals was scheduled for June 22, 1993 at which time a quorum was not present and the meeting had to be recessed until June 29, 1993.
5. Only three members of the Board were present at the June 29, 1993 meeting. Parliamentary procedures were not used in the conduct of the meeting.
6. Following the posting of the property regarding the variance hearing, no objections were heard by the committee regarding the variance.
7. I do not feel that the variance board took into full consideration the facts of this request. The only justifications I was given for not approving the request were that placing a trailer was against the law and that two residences could not be allowed on one lot.
8. I am aware that the Petal Zoning Ordinances do not allow trailers and thus filed a zoning variance request. The ordinances specify that a "lot" in the Rural Fringe must be at least twenty thousand (20,000) square feet. This is less than 1/2 acre of land thus the placement of a second residence on my 96 acres would not violate the lot requirement of my zoning.

I fully understand that the orderly development of a community is vital and desirable, however there are always circumstances that justify deviation from the standard. The City has recognized that in the establishment of a variance board. I feel that this variance would not be detrimental to the current use of my land or the surrounding land and in no way would set a precedent that the officials of Petal would be obligated to uphold for others.

Based on the above facts and the attached documentation, I ask for your consideration in granting this variance.

The PETAL SCHOOL DISTRICT and the CITY OF PETAL, MISSISSIPPI, hereby agree to enter into the following contract whereby the PETAL SCHOOL DISTRICT agrees to the following regulations for serving lunches to SENIOR CITIZENS of Petal, and the CITY OF PETAL further agrees to the following regulations for reimbursement and payment for said SENIOR CITIZENS lunches.

The aforementioned regulations are as follows:
SENIOR CITIZENS meals will be served on Monday and Wednesday of each school session week except on specified school holidays. Said meals will be served by Petal Middle School cafeteria staff.

SENIOR CITIZENS meals will be served by the PETAL SCHOOL DISTRICT beginning promptly at 10:30 a.m. on said days and those SENIOR CITIZENS participating will be completed with their meals before student serving time at 11:00 a.m. SENIOR CITIZENS participating will be responsible for picking up their lunch trays at the service line and taking the lunch trays to the dish room window upon completion of their meals.

SENIOR CITIZENS lunch menus will be the same as that served the students of the PETAL SCHOOL DISTRICT. Copies of said menus will appear weekly in the Petal Journal.

SENIOR CITIZENS participating who wish to bring a guest (grandchildren, children, etc.) will be responsible for paying for said lunches directly to the Food Service Cashier. These extra lunches will not be included in the total count for billing the CITY OF PETAL.

THE PETAL SCHOOL DISTRICT will submit a monthly billing to the CITY OF PETAL for the total number of SENIOR CITIZENS meals served during the specified month. The rate for reimbursement to the PETAL SCHOOL DISTRICT is set at Two Dollars and Fifty cents (\$2.50) per SENIOR CITIZEN meal served.

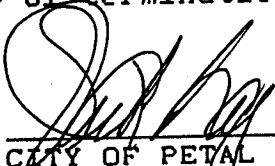
