

AN ORDINANCE CHANGING AND ~~AMENDING~~ <sup>EXHIBIT</sup> "A" THE COMPREHENSIVE ZONING MAP, ADOPTED AS PART OF COMPREHENSIVE ZONING ORDINANCE NO. 1979 (42) OF THE CITY OF PETAL, MISSISSIPPI, AS AMENDED BY ORDINANCE NUMBER 1979 (42-1) THROUGH 1979 (42-A74) SO AS TO CHANGE THE ZONING CLASSIFICATION OF CERTAIN LAND IN SAID CITY FROM R-1 (LOW DENSITY RESIDENTIAL) AND R-2 (LOW TO MEDIUM DENSITY RESIDENTIAL DISTRICT) TO C-1 (NEIGHBORHOOD COMMERCIAL)

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION 1. That the comprehensive zoning map, adopted as part of the Comprehensive Zoning Ordinance Number 1979 (42) of the City of Petal, Mississippi, as amended by Ordinance Numbers 1979 (42-1) through 1979 (42-A74) be and the same is hereby changed and amended as per Petition filed in connection therewith so that the land described as listed below. Change of current zoning classification from R-1 (Low Density Residential District) and R-2 (Low to Medium Density Residential District) to C-1 (Neighborhood Commercial)

PARCEL #161D-2320-01202900-ALL LOT 6 LYING W OF AUGUST ROAD LESS PT TO ROBERT VICK AND E 70 FT OF LOT 9 AND ALL 13 ETHERIDGE SURVEY - PARCEL #161C-01102401 BEG SE CO T N 1/2 S 1/2 NE 1/4 NE 1/4 W 39.5 FT N 16 DEG E TO E LN NE 1/4 S TO BEG

as per map or plat thereof on file in the office of the Chancery Clerk of Forrest County, Mississippi, is hereby classified and placed in the C-1 (Neighborhood Commercial) District of said City.

SECTION 2. Except as expressly changed and amended, the aforesaid Comprehensive Zoning Ordinance Number 1979 (42) of the City of Petal, Mississippi, as amended by Ordinance Numbers 1979 (42-1) through 1979 (42-A74) shall be and remain in force and form as adopted on May 18, 1993.




