RESOLUTION

WHEREAS, the Mayor and Board of Aldermen of the City of Petal are required and mandated to collect and dispose of solid waste within the city limits of the City of Petal, and;

WHEREAS, the City of Petal, pursuant to the provisions of Ordinance No. 1993 (79) controls and supervises the collection and disposal of solid waste within the City of Petal, and;

WHEREAS, the Mayor and Board of Aldermen have found, and do hereby find and determine, that the collection and disposal of commercial solid waste within the City of Petal is not being collected and disposed of pursuant to the terms and provisions of Ordinance No. 1993 (79), and;

WHEREAS, the City of Petal as a member of the Pine Belt Regional Solid Waste Authority is mandated to furnish solid waste for disposal pursuant to the direction of said Authority, and;

WHEREAS, the Mayor and Board of Aldermen have investigated the matter, and find that various solid waste contractors are operating within the City of Petal collecting and disposing of solid waste from commercial locations at varying rates, and;

WHEREAS, the Mayor and Board of Aldermen do hereby find and adjudicate that pursuant to the provisions of Ordinance 1993 (79), its contractual commitments to the Pine Belt Regional Solid Waste Authority and in the best interest of the City of Petal, proposals should be received for the collection and disposal of commercial garbage within the city limits of the City of Petal from a single solid waste contractor.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Petal, Mississippi, that proposals be received from solid waste contractors for commercial garbage collection and disposal for the City of Petal, Mississippi, pursuant to appropriate terms and conditions to be set forth in appropriate contract documents at rates to include container rental, collection and disposal of commercial garbage, and the Mayor and City Clerk are authorized to seek and to obtain proposals in this regard, to be accepted, approved, modified and otherwise acted upon by the Mayor and Board of Aldermen.




To Whom It May Concern,

The referenced site was evaluated by two borings in the only available space for an individual on-site wastewater system. This area was located in the front yard upslope from the residence.

The seasonal water table was located at 8 inches on the first boring and 25 inches on the second boring. The higher seasonal water table may occurred due to fact that surface runoff from the street is not diverted to a ditch but flowing into the yard and standing in this lower area.

Due to the higher of the two seasonal water tables only three options can be recommended for this lot:

- 1) the Wisconsin mound,
- 2) the underground drip irrigation, and
- 3) the use of a lift station to Petal city sewer.

The Wisconsin mound should be located near the driveway which will require the effluent from the septic tank to be pumped to this area. The trees located near the driveway must be removed as well as the grass and organic matter within the mound area.

The underground drip irrigation system will require the installation of a treatment plant and pump chamber. The amount of fill material will be reduced in height <sup>but</sup> will require a larger area.

The lift station will require the homeowner to reach an agreement with the City of Petal prior to installation of the grinder pump so the waste may be disposed of in their system.
