THEREUPON, ALDERMAN SCOTT MADE A MOTION TO ADJOURN. ALDERMAN TIMS SECONDED THE MOTION.



AN ORDINANCE AMENDING ORDINANCE 1977 (36) TO  
CHANGE THE AGE FROM 16 YEARS TO 18 YEARS,  
ESTABLISHING AN EFFECTIVE DATE FOR THE AMENDMENT  
TO THE ORDINANCE, AND FOR RELATED PURPOSES.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF  
PETAL, MISSISSIPPI:

SECTION 1.

SECTION 1 of Ordinance 1977 (36), shall be amended to read  
as follows:

SECTION 1. It shall be unlawful for any person under the  
age of eighteen (18) years to be, or remain in or on any of the  
streets, avenues, alleys or other public places in the City of  
Petal, between the hours of 11:00 p.m. and 6:00 a.m., either on  
foot or in an automobile, or other vehicle, unless such person is  
accompanied by his or her parent or guardian, or other person  
having the legal control and custody of such person, or unless  
such person is in the performance of some duty or mission under  
the direction of his or her parent, guardian, or other person  
having legal custody and care thereof, and shall be engaged in  
such duty or mission, and not loitering upon the streets, alleys,  
avenues or other public places.

SECTION 2.

SECTION 2. of Ordinance 1977 (36), shall be amended to read  
as follows:

If any minor under the age of eighteen (18) years. shall  
violate the provisions of this Ordinance, he or she shall, upon  
conviction, be fined in an amount not to exceed \$25.00.

SECTION 3. of Ordinance 1977 (36), shall be amended to read  
as follows:

It shall be unlawful for any parent or guardian or other  
person having the legal care, custody, and control of a person  
under the age of eighteen (18) years to permit any such person to  
go upon the streets, alleys, avenues, or other public places of  
the City of Petal between the hours of 11:00 p.m., and 6:00 a.m.,  
either on foot or in an automobile or other vehicle, except as  
provided in Section 1. hereof.

SECTION 4. Any parent, guardian, or other person having the legal care and custody of a person under the age of eighteen (18) years, who shall permit such person to violate Section 1 hereof, shall upon conviction, be fined in a sum of not more than \$25.00.

SECTION 5. Remains unchanged.

SECTION 6. Remains unchanged.
