The following is a brief report on what has happened recently at our apartment complex. We were advised to forward this to you for your assistance in helping us to recoup some of the expenses incurred in the following.

On November 6, 1997, we discovered water seeping through concrete at our apartment complex, Cameron East, located at 209 Dixie Ave., Petal. The Petal Water Department was called. We were told we would have to handle it ourselves. Dye & Gunn was hired to repair the main water line leak. We paid to remove concrete and locate the leak. Mr. Gunn insisted this was city property and city water officials concurred. City employees repaired the leak. The following day we had a call that an apartment was flooding. After an extensive search for the water leak it was located on a line going to the hot water heater behind and under the kitchen bar. Large amounts of sand was on the floor. The water heater was half full of sand. We have the water heater on hand for your inspection. Our repairman feels the problem was caused by your repairman allowing sand to enter the main water line. We have paid several service calls to remove sand from strainers at other apartments in the complex.

We feel the City of Petal is responsible and we would like to be reimbursed. Attached are a couple of invoices that were paid. Please note that this is just a portion of the expenses that has arose from the main water line leak.

I would like to add that the forman was very cordial and the repair crew seemed very knowledgeable. I feel this was just an unfortunate accident.
