RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN

WHEREAS the Mayor and Board of Aldermen have factually determined that use and utilization of the City's firemen and fire fighting equipment outside the city limits of the City of Petal will lead to a circumstance of lives and property within the City of Petal being inadequately protected; and

WHEREAS the Mayor and Board of Aldermen have previously authorized the City of Petal to enter into a mutual aid agreement with fire departments in Lamar County, Mississippi and Forrest County, Mississippi requiring certain mutual aid and assistance, which is not in the best interest of the City of Petal, and should be unilaterally amended; and

WHEREAS the Mayor and Board of Aldermen of the City of Petal, Mississippi, are authorized to take the action which it now seeks to accomplish, it is

THEREFORE resolved, that the City of Petal unilaterally amends its obligations pursuant to its mutual aid agreements with fire departments in Lamar County and Forrest County, Mississippi, as follows, to-wit:

1. Upon request of a volunteer fire department, a county fire department, or a city fire department or a senior municipal law enforcement officer, the Petal Fire Department may respond, if deemed advisable by the senior officer on duty, outside the city limits to commercial, school, and public assembly emergencies only.

2. That for cities, counties, and volunteer fire departments, outside of Forrest and Lamar County, the City of Petal Fire Department may render mutual aid and assistance upon request, if deemed advisable by the fire chief, acting fire chief, or other senior fire official on duty, or upon the direction of the Mayor of the City of Petal to respond to commercial, school, or public assembly emergencies.

ORDINANCE NUMBER 1979 (42-A104)

AN ORDINANCE CHANGING AND AMENDING THE COMPREHENSIVE ZONING ORDINANCE NO 1979 (42) OF THE CITY OF PETAL, MISSISSIPPI, AS AMENDED BY ORDINANCE NUMBERS 1979 (42-1) THROUGH 1979 (42-A103) SO AS TO CHANGE THE ZONING CLASSIFICATION OF SAID SECTIONS OF CERTAIN LAND IN SAID CITY FROM R-2 (LOW TO MEDIUM RESIDENTIAL DISTRICT) TO C-I (NEIGHBORHOOD COMMERCIAL)

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI:

SECTION 1. That the Comprehensive Zoning District Map, adopted as part of the Comprehensive Zoning Ordinance Number 1979 (42) of the City of Petal, Mississippi, as amended by Ordinance Numbers 1979 (42-1) through 1979 (42-A103) be and the same is hereby changed and amended as per petition filed in connection therewith so that the land described as listed below. Change of current zoning classification from R-2 (Low to Medium Residential District) to C-I (Neighborhood Commercial)

Said land being more particulary described as follow, to wit:
