#### **SECTION 1**

#### NARRATIVE DESCRIPTION AND BUDGET

- A. Periodic enforcement checks: (\$22,000.00) It shall be the goal of our department to conduct random, unannounced inspections during the grant period at 100% of the locations where tobacco products are sold in our city. This will be accomplished at a rate of approximately 10% per month. This goal will be achieved by a combination of visual inspections by a law enforcement official, and controlled buys with minors.
- B. Youth Advisory Board: (\$2,000.00) A Youth Advisory Board recruited from the local schools will work on various issues including enforcement, education, and lobbying city hall for necessary ordinances to assist in the elimination of access to, and possession and use of, tobacco products by juveniles.
- C. Community Groups: (\$2,000.00) Presentations will be made to civic groups including the Chamber of Commerce, Optimist Club, Kiwanis Club, and other community groups which will explain "The Mississippi Juvenile Tobacco Access Prevention Act" and the police department's plan to educate the retail sellers, conduct compliance checks, and involve the public in our efforts to reduce the access to and use of tobacco by the children on our state. We will solicit the assistance of these groups to spread the word and encourage compliance with the Act.
- D. Retailer Compliance Education: (\$2,000.00) The required biannual training sessions will be accomplished by a combination of city-wide seminars and employee meetings at the larger businesses. Retailers who do not participate in the seminars will be visited individually and offered the training at times and locations convenient for them.
- E. Minority Population of Jurisdiction: (\$1,000.00) Representatives from the minority community will be actively recruited and included in the Youth Advisory Board. Input will be actively solicited from minority members of civic groups and other organizations.
- F. Efforts to achieve 75% or greater prosecution rate: (\$1,000.00) Training sessions will be held with law enforcement officers to inform them of the provisions of the Act and the documentation required. Coordination will be made with the city prosecutor to ensure that the cases are properly prepared. Teenagers who are used to purchase tobacco products in compliance checks will be properly trained. Equipment will be purchased which will document evidence of violations.
- G. Technical and Economic Feasibility of Project: The Petal Police Department intends to use current full time staff, current reserve officers, and possibly one contract supervisor to accomplish the above tasks. In addition, the Petal Municipal Separate School District police officer will incorporate the health risks of using tobacco products and "The Mississippi Juvenile Tobacco Access Prevention Act" into the drug education program which he conducts at the schools. The police department has been actively enforcing the alcohol law, and those assets and personnel will provide valuable expertise in enforcing the tobacco law. Current equipment will be utilized, when available. However, it is necessary that the following equipment be purchased in order to conduct periodic enforcement checks:
  - 1. Video camera
  - 2. police radios
  - 3. tape recorder(s) or body wires, receiver and recorder
  - 4. vehicle (if seized vehicle cannot be obtained)
  - 5. Cell Phone
  - Pagers

The following equipment will be purchased for use in presentations to youth advisory boards, community groups, and retailers:

- 1. Video Cassette Players
- 2. Overhead Projector and Screen
- 3. Computer software for preparing presentations
- 4. Copy machine for preparing transparencies (also for other office uses)

The following equipment will be purchased for general office uses relating to administering this program:

- 1. Computer, software, modern, and color printer for e-mail correspondence with the Attorney General's office, preparing required letters, affidavits, citations and reports.
- 2. FAX machine for sending messages and correspondence to the office of the Attorney General, other agencies, and retailers.
- 3. Computer desk and chair.
- 4. Lap top computer for the supervisor to use when not at the office.
- 5. Additional telephone line for police station to be used for the computer and fax machine.

# SECTION 2 Description of the City of Petal

The city of Petal is located in the northeastern part of Forrest County. US highway 11 and MS highway 42 intersect on the western side of the city near the Leaf River and the boundary with the city of Hattiesburg. The population is approximately 8000 within the city. The people of several small communities within nearby Forrest, Perry, and Jones Counties trade in the city. There are several convenience stores within the city, with others presently under construction. The Petal Separate School District has two campuses within the city and two schools outside the city on Highway 42 east. The total school population is 3300 students. Other information is attached. It is felt that the major tobacco usage by our youths is smokeless tobacco followed closely by cigarettes. At the present time the major challenge in preventing our juveniles from purchasing tobacco will be educating the retailers and retail clerks. A recent unscientific survey indicates ignorance of the provisions of the tobacco act.

# SECTION 3 Cooperative efforts

As stated earlier, we will have the assistance of the Petal School District Police Department in our education efforts at the schools. The school district will also be contacted for their assistance in organizing the Youth Advisory Board.
