CITY OF PETAL ORDINANCE

AN ORDINANCE BY THE CITY OF PETAL, MISSISSIPPI PROHIBITING THE USE RETEMPACED AND/OR TOBACCO PRODUCTS BY JUVENILES.

WHEREAS, the City of PETAL, pursuant to Section 21-17-5 of the Mississippi Code, is authorized to adopt ordinances with respect to its municipal affairs which are not inconsistent with the Mississippi Constitution of 1890, the Mississippi Code of 1972, or any other statute or law of the State of Mississippi; and

WHEREAS, the City of PETAL, pursuant to Section 21-19-1 of the Mississippi Code, is authorized to make regulations to secure the general health of the municipality; and

WHEREAS, the City of PETAL, has the duty to protect and promote the health of its citizenry; and

WHEREAS, the City of PETAL, in order to promote and protect the health of its citizenry, finds that the use of tobacco and/or tobacco products by the juveniles of this City is a significant public health problem with serious personal health consequences; and

WHEREAS, the City of PETAL, in order to promote and protect the health of its citizenry, finds that sixty Mississippi juveniles start using tobacco and/or tobacco products every day.

WHEREAS, the City of PETAL, in order to promote and protect the health of its citizenry, finds that one out of three juveniles who use tobacco and/or tobacco products will eventually die from a tobacco-related illness.

THEREFORE, BE IT ORDAINED, by the City of PETAL, as follows:

Section 101. Definitions.

- a. "Tobacco and/or Tobacco Product" shall mean any substance that contains tobacco including, but not limited to, cigarettes, cigars, pipes, snuff, smoking tobacco or smokeless tobacco.
- b. "Juvenile" shall mean any person under the age of eighteen (18).
- "Use" shall mean the smoking, chewing, oral consumption, spitting, inhaling or other ingestion of tobacco and/or tobacco products.
- d. "Educational Property" means any elementary or secondary school building or bus, school campus, grounds, recreational area, athletic field, or other property owned, used or operated by a school board or board of trustees or directors for the administration of any educational institution.
- e. "Educational Activity or Function" means a school sponsored event for athletics, academics, social or entertainment purposes, attended by students, including school transportation to and from, regardless of whether such activity is held on educational property.

Section 102. Use of Tobacco/Tobacco Products by Juveniles Prohibited. It shall be unlawful for any juvenile to use tobacco and/or tobacco products within the city limits of the City of PETAL and/or any educational property.

Section 103. Possession of Tobacco/Tobacco Products by Juveniles Prohibited. Except where the possession of tobacco products by juveniles is restricted by Miss. Code Ann. 97-32-9, it shall be unlawful for any juvenile to possess tobacco and/or tobacco products within the city limits of the City of PETAL.

Section 104. Violation of Ordinance by Javeniles. Any juvenile who is found guilty of violating this ordinance shall be punished as follows:

- 1. For a first conviction, a fine of no more than \$100.00 Dollars or 30 hours of community service.
- For a second conviction, a fine of \$100.00 Dollars or 50 hours community service, or both
- For a third conviction, a fine of \$100.00 Dollars and 75 hours of community service

Section 105. Additional/Alternative Punishment. In addition to or as an alternative to imposing punishment as prescribed in Section 104, the court may require any juvenile who is found guilty of violating this ordinance to attend and complete a Tobacco Cessation and/or Educational Program as approved by the court. Those juveniles found guilty of violating this ordinance who are required to attend one or both of the programs provided above, my be required to pay for the reasonable costs of their attendance and completion of such program.

Section 106. Severability. If any section, clause, paragraph, sentence or word of this ordinance is for any reason held to be unconstitutional, void or unenforceable, such invalid provision shall not affect the remaining portions of this ordinance nor render them invalid, and to this end the provisions of this ordinance are declared to be severable.

Section 107. Date of Effect. This ordinance shall take effect and be in force thirty (30) days after its passage.

Section 108. Conflicting Ordinances, Resolutions and Orders Repealed. All ordinances, resolutions and orders in conflict with this ordinance are hereby repealed to the extent of the conflict at the date of effect of this ordinance.

2. For a second conviction, a fine of \$100.00 Dollars or 50 hours community service, or both $\,$
