WHEREAS, the Mayor and Board of Aldermen of the City of Petal, Mississippi, are authorized pursuant to 17-21-51 of the Mississippi Code of 1972, as amended, to borrow money, in their discretion, to accomplish any purpose not otherwise prohibited by law, in sums not exceeding \$138,000.00; and

WHEREAS, the Mayor and Board of Aldermen of the City of Petal, Mississippi, have investigated and determined the reasonableness and necessity for borrowing the sum of \$138,000.00 for payment to the City of Hattiesburg for capital improvements to the south sewer lagoon; and

WHEREAS, the borrowing of said funds is within the borrowing limit of the City of Petal and said borrowing will be secured by the full faith, credit, and resources of the City of Petal, which are pledged as security for principal and interest on said note or notes; and
