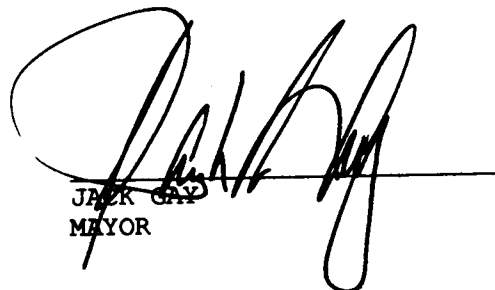

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF
PETAL, MISSISSIPPI:

SECTION 1 THAT THE COMPREHENSIVE ZONING DISTRICT MAP, ADOPTED AS
PART OF THE COMPREHENSIVE ZONING ORDINANCE NUMBER 1979 (42) OF THE
CITY OF PETAL, MISSISSIPPI, AS AMENDED BY ORDINANCE NUMBERS 1979 (42-1)
THROUGH 1979 (A-108) BE AND THE SAME IS HEREBY CHANGED AND AMEDNED
AS PER PETITION FILED IN CONNECTION THEREWITH SO THAT THE LAND
DESCRIBED AS LISTED BELOW. CHANGE OF CURRENT ZONING CLASSIFICATION
FROM R-F (RURAL FRINGE) TO R-1 (LOW DENSITY RESIDENTIAL).

SECTION 11. EXCEPT AS HEREBY EXPRESSLY CHANGED AND AMENDED, THE AFORESAID COMPREHENSIVE ZONING ORDINANCE NUMBER 1979 (42) OF THE CITY OF PETAL, MISSISSIPPI, AS AMENDED BY ORDINANCE NUMBERS (1979 42-A108) SHALL BE AND REMAIN IN FULL FORCE AND FORM AS ADOPTED ON JULY 5TH, 2000.

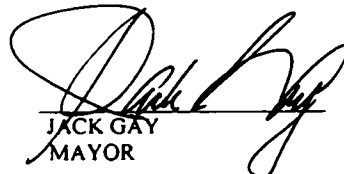

SECTION 14 (A). The following schedule of rates is hereby ascertained, found, and declared to be reasonable, and the same are hereby established as the rates to be charged for water, subject to minimum charges shown below:

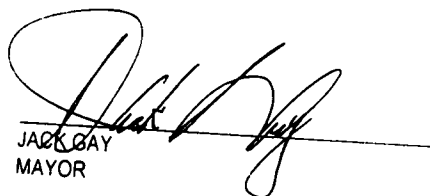

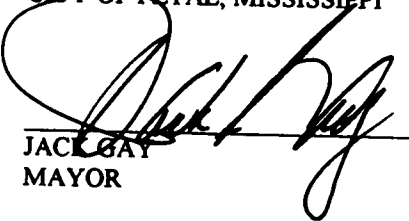
