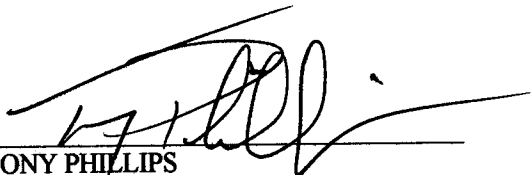

ORDINANCE NUMBER 1984 (57) F  
OF THE CITY OF PETAL, MISSISSIPPI

AN ORDINANCE AMENDING SECTION 14 (A) OF ORDINANCE 1984 (57) E OF THE CITY OF PETAL, MISSISSIPPI, SO AS TO CHANGE THE CHARGES FOR WATER USE WITHIN THE CITY OF PETAL, MISSISSIPPI, REPEALING SECTIONS IN CONFLICT THEREOF, AND FOR RELATED PURPOSES.

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Petal, Mississippi:

SECTION 1. Section 14 (A) of Ordinance Number 1984 (57) E as originally adopted and subsequently amended is hereby amended to read as follows, to wit:

SECTION 14 (A). The following schedule of rates is hereby ascertained, found, and declared to be reasonable, and the same are hereby established as the rates to be charged for water, subject to minimum charges shown below:

RATE SCHEDULE FOR WATER/SEWER  
RESIDENTIAL AND COMMERCIAL

Per 1,000 Gallons	Water	Sewer
Minimum up to 3,000	\$9.90	\$3.00 Minimum up to 1,000
For each additional 1,000 gallons used	\$2.20 per thousand	.50 per thousand

SECTION 2. All ordinances in conflict herewith, be, and are hereby repealed.

SECTION 3. That this ordinance shall take effect, and be in force (30) days from and after its passage.
