# **ORDINANCE NO. 2002 (101)**

AN ORDINANCE REQUIRING MANDATORY FLOW OF MUNICIPAL SOLID WASTE, ESTABLISHING PENALTIES FOR VIOLATION THEREOF, ESTABLISHING AN EFFECTIVE DATE AND FOR RELATED PURPOSES

BE IT ORDAINED BY, the Mayor and Board of Aldermen of the City of Petal,

Mississippi, to wit:

SECTION 1. The Mayor and Board of Aldermen of the City of Petal, Mississippi, do hereby find and declare:

- a. The City of Petal, Mississippi, has received a certified copy of a resolution adopted by the Pine Belt Regional Solid Waste Management Authority (The Authority) dated July 10, 2002, directing each member of The Authority to adopt a resolution or ordinance to require the mandatory flow of municipal solid waste to The Authority solid waste landfill in Perry County, Mississippi, a copy of the resolution of The Authority received by the City of Petal, Mississippi, being attached hereto as Exhibit "A".
- b. The City of Petal, Mississippi, is a member of The Authority and is required to adopt such an ordinance pursuant to the terms and provisions of §17-17-319 (Supp. 2002) of the Mississippi Code of 1972.

SECTION 2. For the purposes of this ordinance, the following words and phrases shall have the meaning herein:

- a. Municipal Solid Waste means any non-hazardous solid waste resulting from the operation of residential, commercial, governmental, industrial or institutional establishments, except oil field exploration and production waste and sewage sludge.
- b. Person means a person as defined in §17-17-3 of the Mississippi Code of 1972.

SECTION 3. All municipal solid waste generated within the geographic boundaries of the City of Petal, Mississippi, that is placed in the waste stream shall be transported to, stored and managed at the Pine Belt Regional Solid Waste Management Authority's landfill in Perry County, Mississippi, or at a transfer station owned by the Pine Belt Regional Solid Waste Management Authority.

SECTION 4. It shall be unlawful for any person to violate any provision of this ordinance. Such violation shall be a misdemeanor, and shall be punishable by a fine of not more than one thousand dollars (\$1,000.00), or imprisonment for a term not exceeding ninety (90) days, or by both such fine and imprisonment at the direction of the municipal judge. If a violation is continuing, each day's violation shall be deemed a separate offense.

SECTION 5. This ordinance shall take effect and in full force from and after thirty (30) days from the adoption and passage hereof.

# RESOLUTION DECLARING NECESSITY OF REQUIRING MANDATORY FLOW OF MUNICIPAL SOLID WASTE

WHEREAS, the Pine Belt Regional Solid Waste Management Authority ("the Authority") is a regional solid waste management authority created under the provisions of Miss. Code Ann. §§ 17-17-301 through 17-17-319, and

WHEREAS, the Authority operates a solid waste landfill in Perry County, Mississippi, as defined by Miss. Code Ann. § 17-17-305(w), and

WHEREAS, under Miss. Code Ann. § 17-17-319, the Authority may determine if the mandatory flow of municipal solid waste to its facility is necessary to ensure the viability of the facility,

NOW, THEREFORE, Be it resolved as follows:

That the Authority hereby determines that the mandatory flow of municipal solid waste to the Authority's solid waste landfill in Perry County, Mississippi, by any person located or residing within the territorial boundaries of a member of the Authority is necessary to ensure the viability of the Authority's facility in Perry County, Mississippi, and each member of the Authority is directed to comply with this resolution by adopting a resolution or ordinance to require such mandatory flow.
