

EXHIBIT "A"

AN ORDINANCE TO AMEND ORDINANCE 1975 (25-A)  
INCREASING THE ELECTRICAL LICENSE FEE AND  
PROVIDING FOR PENALTIES FOR LATE RENEWALS

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF CITY OF  
PETAL, MISSISSIPPI:

SECTION 1: Section 2, Part 2 (4) of Ordinance 1975 (25-A) is hereby  
amended to read as follows:

SECTION 2, Part 2 (4) To authorize the issuance of the license applied for  
upon qualifications of such applicant, and the payment of a Fifty Dollar (\$50.00)  
fee for the issuance of said license to the City Building Department upon an  
annual basis; applicants shall have a fifteen (15) day grace period following  
expiration of the original license. Licenses renewed sixteen (16) days to sixty  
(60) days after the renewal date will require a fee of Sixty Dollars (\$60.00) and  
renewals after sixty (60) days from the renewal date will be required to pay a  
license fee of Seventy Dollars (\$70.00).

SECTION 2: Except as otherwise amended herein, Ordinance 1975 (25-A)  
be, and the same shall hereby remain in full force and effect.

SECTION 3: This Ordinance shall be in full force and effect thirty days  
from and after its passage and approval as provided by law.
