The Purpose of this General Order is to set forth policies regarding the use of restraint systems while operating City of Petal Vehicles.

Children under the age of (4) four years shall be protected as required by section 63-7-103 through 63-7-313.

LETTER OF AGREEMENT FOR PLANNING AND CONSULTING SERVICES

THIS AGREEMENT is entered into by and between BRIDGE & SLAUGHTER, LLC, hereinafter called the CONSULTANT and the CITY OF PETAL, MISSISSIPPI, hereinafter called the CITY.

- The CITY does hereby employ the CONSULTANT to perform professional and technical services for: REDISTRICTING STUDY.

- Prepare up to two (2) redistricting plans for the alderman's election districts, which include

In the event that the CITY desires to have <u>more</u> than two (2) alternates prepared, or conduct more than four (4) meetings, the CITY will be responsible for compensating the CONSULTANT at its hourly rate plus expenses for the additional alternates.

The CONSULTANT will submit monthly or periodic invoices to the CITY requesting payment. Such requests will be based upon the amount and value of work and services performed by the CONSULTANT and will be accompanied by an itemized statement of work performed. The CITY shall pay the CONSULTANT the total amount of the invoice within thirty (30) days after receipt of the invoice. Nonpayment or payment less than the amount of the invoice within the specified time shall be cause for suspension of work by the CONSULTANT. The invoices will be based on the following rate
