PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY

WHEREAS, THE PETAL CITY COUNCIL does hereby find:

That conditions of extreme peril to the safety of persons and property have arisen

Within said the City caused by HURRICANE KATRINA

Commencing on or about 12 a.m./(p.m.) on the 27th day of

August, 2005:

That the aforesaid conditions of extreme peril warrant and necessitate the proclamation

Of the existence of a local emergency;

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that in accordance with Section 33:15-17, MS Code of 1972, a local emergency now exists throughout said County; and

IT IS FURTHER PROCLAIMED AND ORDERED that said local emergency shall be deemed to continue to exist until its termination is proclaimed by the Mayor and City Council of the City of **PETAL**, Forrest County, State of Mississippi.
